1. The Judicial Officers whose names are mentioned in Column A and B above shall hold the Courts physically on the dates mentioned in their column, from 10:00 AM to 01:30 PM and 02:00 PM to 04:00 PM and virtually on other working day when they are not rostered physically. On physical hearing days, the Courts shall permit hybrid hearing where a request to such effect is made by any of the parties and/or their counsel.

2. All Courts shall keep their web links open on each working day from the start of the Court functioning, which is 10:00 AM till the Court holds its sittings so that any counsel/party wishing to join virtually is able to join the proceedings even without any prior intimation.

3. The aforesaid arrangements shall continue up till 28.02.2022 and from 02.03.2022 there shall be complete resumption of physical hearings in the Delhi District Courts. After complete resumption of physical hearing, the Courts may, in exceptional circumstances on a case-to-case basis, permit hybrid/video-conferencing hearing.

4. Special request for physical hearing for a fresh bail application shall be entertained by the ASJ rostered for that Police Station or the link ASJ.

5. In case an Advocate(s) makes request for bail application to be heard physically, the Addl. Sessions Judge rostered to hear bail application shall list the bail application on a day when he is holding court physically. In case the matter requires hearing on a day when the ASJ is not rostered on physically then it shall be heard by the link ASJ.

6. The Judicial Officers shall hold physical hearing in their respective court rooms on dates mentioned in the roster.

7. The duties to Metropolitan Magistrate shall be assigned by the Chief Metropolitan Magistrate (South West) District, Dwarka Courts, New Delhi.

8. In the absence of undersigned, Sh. Harish Dudani, District Judge (Commercial Court) and in his absence Dr. Vijay Kumar Dahiya, Addl. District Judge-01, Dwarka Courts shall be the Officiating Principal District & Sessions Judge.

9. All the staff members posted in branches as well as courts at South West District, Dwarka Courts shall be present on all the working days.

10. The Advocates, staff officials, litigants and other visitors to the Courts shall follow all the COVID-19 protocols, guidelines, directions, etc. issued by the Govt. of India, Govt. of NCT of Delhi and Hon'ble High Court of Delhi, New Delhi from time to time.

11. In order to restrict the footfall, only those litigants shall be allowed entry into the Courtroom(s) whose appearance is recommended by their respective counsel or who are appearing in person or whose presence has been directed by the Court.
