### **ORDERS**

- With respect to staff (except orderlies) posted in various Courts in Dwarka District Court Complex, the physical presence or virtual attendance of the staff shall be at the discretion of the respective Presiding Officers.
- The Orderlies shall physically report in the concerned Courts/Branches.
  Spare orderlies shall report in the Administration Branch.
- 3.1 There shall be no exemption for the Senior A.O./A.O./D.D.O./Branch Incharge(s) from physical attendance in the office. The remaining staff shall attend the office physically atleast to the extent of 50% (fifty percent) of the staff posted in a particular branch.
- 3.2 The Branch Incharge(s), with prior approval from concerned Officer-in-Charge(s) (OICs), shall prepare roster of the officials to attend the office physically.
- 4. Attendance of the officials physically present in office shall be marked in concerned Courts/Branche(s) and be sent to the Administration Branch.
- 5. The Branch Incharge, Facilitation Centre shall be at liberty to permit some of the officials to work from home.
- 6. No official shall leave the station without prior permission.

Further, the staff attending the office physically is hereby again directed to strictly adhere to the various Safety, Hygiene & Social Distancing norms to ensure effective fight against the ongoing pandemic.
