GENERAL INSTRUCTIONS TO BE FOLLOWED WHILE FILLING UP 'APPLICATION-CUM-CONSENT LETTER' FOR BEING DESIGNATED AS SENIOR ADVOCATE

- Every Application-cum-Consent Letter, in the prescribed format shall be made in English, typed/printed with font size (Arial-14) in double spacing on both sides of the white paper (A4 Size) with an inner margin of about four centimeters width on top and on the left side.
- Documents accompanying the Application should be numbered consecutively in the Index, in all sets of Application.
- 3. All documents annexed to the Application should be accompanied by an Index containing the details thereof. (The Registry, at any stage, may ask for the supportive documents for verification in the light of the facts mentioned in the Application).
- Name of the Applicant should ally with his/her name as mentioned in his/her enrolment certificate. Abbreviated name shall NOT be accepted.
- The Application should be presented in the shape of a Paper Book, duly tagged & indexed and not in spiral binding and the like.
- (i) All photocopies of the accolades/testimonials should be legible and true copy of their respective originals.
 - (ii) English translation of vernacular documents (if any) should be annexed thereto.
- 7. 10 sets of the Application in the form of Paper Book, identical in all respects;
- 8 (i) Passport size photograph (original) should be pasted on each copy of the Application-cum-Consent Letter.
 - (ii) One additional recent passport size photograph (mentioning the name of the applicant on its back side) should be provided in a separate envelope.
- Information relating to Columns 15, 16, 17, 19 and 23 should be submitted in the prescribed formats attached with these instructions.
