contacted the Administrative Officer (Judl.) telephonically. The Advocate(s) shall speak to the Administrative Officer (Judl.) on phone and convey the extreme urgency involved. Only thereafter necessary instructions will be issued by the Administrative Officer (Judl.) to the Facilitation Centre for accepting the case.

- (b) Advocates/ Parties making call to Administrative Officer (J) shall maintain decency and stick to office hours i.e., 10 AM to 04 PM.
- The Officers of Delhi Higher Judicial Services and Delhi Judicial Services rostered for extremely urgent will be available on phone call and shall have the liberty to attend to the matter in the Court premises or at his/her residence.
- 3. For fresh matters of extreme urgency, Administrative Officer (Judl.) will contact the rostered Officers and seek his/her convenience for attending the matter in the Court premises or at his/her residence.
- 4. (a) Ms. Usha Khattar, Sr. Administrative Officer (Judl) Mob. No. 9891204839, 7011765585 is directed to entertain the extreme urgent request for filing of extremely urgent matters. In case of Ms. Usha Khattar, Sr. Administrative Officer (Judl) not being available, Ms. Manju Bindra, Sr. Administrative Officer (Judl), Mob. No. 9910828209 shall be Link Administrative Officer (Judicial).
 - (b) In pursuance to order No.2/RG/DHC/2020 dated 29.03.2020 of the Hon'ble High Court of Delhi, New Delhi, the DHJS Officers on duty on a particular day shall take final decision with respect to the urgency of the matter. The Ld. Judicial Officer may take up the matter on that day itself or adjourn it to further date, depending upon the urgency of the case. The Administrative Officer (Judl.) shall refer the matter to the senior most DHJS Officer on duty to take the final decision.
- 5. Judicial Officers shall be assisted by their own Court staff. The Judicial Officers shall depute the staff as per requirement and the Judicial Officer shall depute only those staff officials who are residing in Delhi and are using their own conveyance. In case of in-sufficiency or non-availability of the staff in any of the aforesaid Courts, the Administrative Officer (Judl.) shall ensure the staff for aforesaid court taking into consideration that only court staff residing in Delhi and using their own conveyance are called for duties.

- The Judicial Officers/officials who are not called for duties, shall remain available for duties on phone call and shall not leave the station, under any circumstances.
- 7. In case of urgency or unavoidable circumstances, if the rostered Judicial Officer(s)/Official (s) is not able to perform his/her duty on the dates mentioned against his/her name then he/she shall take the willingness of other Judicial Officers/Official and send the request letter to the Office of undersigned or their concerned Judicial Officer/Officer Incharge for change of duty.
- 8. The abovesaid directions shall remain in-force till **03.05.2020** or until further orders.
