



Whenever any Ld. MM (Reliever) is on leave or busy in remand proceedings in Hospitals etc., or is not available due to any reason, the court work of (Column No. B) shall be looked after by the regular Link MM as per link roster D-114/LR/CMM/VKM/2021/Delhi dated 16.03.2021 and only the TIP application or recording of statement U/s- 164 Cr.P.C shall be looked after by the Link MM (Reliever) shown in Table No. 2. In case both the said MMs (Reliever) are on leave or not available for similar reason, the MMs whose name is mentioned immediately below the name of the MM (Reliever) concerned shall work as next link MM. In case even the next link MM (Reliever) mentioned immediately below the name concerned MM on leave or similarly not available, the link MM (Reliever) whose name is mentioned immediately below thereafter shall work as next link horizontal line shall duration and so on & so forth. The aforesaid arrangement shall be operative in absence of specific order of undersigned to the contrary.


