Necessary relaxation to the norm of submitting the declaration form, in person, was also provided on subjective basis to those members of Bar who were aged (65 Yrs. & above)/infirm, hospitalized, unwell (have been prescribed rest), expecting mothers and others, facing some other genuine difficulty/unavoidable circumstances. The declaration forms of such members were being received through their authorized persons/family members, subject to scrutiny and satisfaction of this committee.

It has now been represented before the committee that some medium of acceptance of the declaration forms may be established for the benefit of those members also, who are facing genuine difficulties and who can neither deposit the forms in person, nor through some family member/authorized person.

In order to ensure that no hardship is caused to the genuine voters, it has now been decided that the persons falling under the above discussed categories (infirmity/illness/hospitalization/under-treatment/outstation) their may send declaration forms alongwith valid ID Proofs and their supporting documents/proofs/certificates of the hardships being faced by them, on the given e-mail id i.e. dcba.electioncommittee.2021@gmail.com.

The forms thus received shall be considered by the committee on case to case basis, and the applicants would be allowed as valid voters, only after they appear in-person before the committee and confirm to have deposited the forms. Such members/applicants would be intimated on their given e-mail IDs, about the date/s when the committee would consider their cases for physical appearance.

Any declaration forms received through e-mail, without any valid ground of difficulty or without proper supporting documents, would not be considered by the committee. Further, any declaration forms received on the given e-mail, after 5:00 PM on 24-12-2021 would also not be considered.

The whole exercise is being done, in order to ensure that only genuine declaration forms are received and no hardship is caused to the genuine members. Maximum co-operation of all the concerned is solicited, so that the process of voter list finalization could be concluded by the committee, at the earliest possible.
