ORDER

In terms of the directions of the Hon'ble High Court of Delhi, issued vide order No.72/DHC/Gaz./2018 dated 15.10.2018, a scheme for redressal of grievance of the Member the Bar in the Delhi District Courts has been framed. The scheme put into place mandates for creation a committee at District Court level to resolve the issue if any between the Bar and Bench and over come challenges to make justice delivery system for efficiency.

The mechanism so visualized will not only provide a platform to address concerns raised by Members of the Bar, but will also serve as vehicle to achieve the cherished constitutional goal of a robust and speedy justice dispensation system. The committee for redressal of concerns of members of the Bar Association at South West District, Dwarka Court is constituted as under with immediate effect:

2	Administrative Civil Judge, (S-W)	Convenor
3	President, Dwarka Court Bar Association,	Member
4	Hony. Secretary, Dwarka Court Bar Association	Member
5	Sh. Ajayinder Sangwan, Hony. Secretary, Bar Council of Delhi	Member

The scope of the work of the above mentioned committee for dealing with the concerns of members of the Bar of District Court is as under:

- (i) To make recommendations for smooth functioning of the court(s);
- (ii) To facilitate amicable resolution of functioning of the problems faced by the Members of the Bar in respect of functioning of the concerned District Court or its Registry-limited to procedural and logistical matters but excluding complaints about the conduct of any Judge;
Complaints against Judicial Officers shall not be looked into by the above mentioned Committee and the same shall continue to be put up before the Hon'ble Inspecting Judges Committee or the Hon'ble Vigilance Committee for members of DHJS and DJS, as the case may be.
- (iii) To facilitate amicable resolution of issues concerning the Police.
- (iv) To make appropriate recommendations to the respective BMCC of the High Court of the concerned court complex.

Note:- 1) The work of the above said committee will be looked after by the Judicial Branch.
2) Any correspondence with the Hon'ble High Court of Delhi is to be done through the undersigned.
