4) All the concerned Judicial Officer/s are requested to direct their staff to retain the pending bail application/s with them during their roster tenure and direct them to do all the necessary compliance in terms of the order passed in the bail application/s. However, the decided file/s be sent to the Facilitation Centre, on day-to-day basis, positively by 04:00 P.M.
