c) All criminal appeal, revision, bail applications/Misc. Urgent applications, Misc. documents for the establishment of Principal District & Sessions Judges in criminal cases shall be filed through email at facilitationsw.ddc@gov.in.

d) All criminal complaints, bail applications/Misc. Urgent application for the establishment of CMM shall be filed at <u>cmmoffsw.ddc@gov.in</u>

e) In criminal matters, the request for exemption from personal appearance of the accused, be considered favourably.

f) Parties/advocates/witnesses seeking an adjournment be accommodated.

g) All court staff members are directed to strictly adhere to the social distancing norms and download and install the Aarogya Setu. All the stakeholders are advised to get themselves vaccinated at the earliest as per the norms issued by Government from time to time.

h) All the Under trial Prisoners (UTPs) be produced through video conferencing.
