<u>ORDER</u>

In partial modification of earlier order No. 9182-9262/DJ/NK/DWK/2020/LKD dated 16.06.2020 to deal with the cases of COVID-19, affected/suspected Judicial Officers/Officials posted at South-West District, Dwarka Courts, the following arrangements are hereby made:

1) A Committee named 'Quarantine Committee' is hereby re constituted as under:

- 2) In case any Judicial Officer/Official himself, or any of his family member(s) residing with him, tests positive for COVID-19, the said Officer/Official shall immediately inform the 'Quarantine Committee' and the Nodal Officer appointed by the undersigned.
- 3) The affected Judicial Officer/Official shall avoid any kind of interaction with any person in the Office/Court Complex during the period of his treatment of COVID-19.
- 4) In case any Judicial Officer/Official is advised by some Doctor, or he himself considers it necessary, to proceed to isolate/quarantine himself, for the reason that he has come in direct contact with some COVID-19 patient, the concerned Judicial Officer/Official shall make a written request to proceed on quarantine, to the 'Quarantine Committee'.
- 5) The Judicial Officer/Official shall proceed on quarantine only after submission of necessary medical/supporting documents via WhatsApp or any other electronic mode to the said Committee and its approval by the Committee. The Committee shall consider and decide each case keeping inview the facts and circumstances of the same.
- 6) In case any Judicial Officer/Official who is not approved by the 'Quarantine Committee' to proceed on quarantine fails to attend to his/her duties as assigned to him/her, he/she shall be treated on leave.

Violation of these directions shall entail serious consequences.
