Chief Metropolitan Magistrate/Metropolitan on duty for extension of Judicial Custody remand of UTPs as per duty roster/s issued by CMM, (South-West), District Courts, Dwarka, shall in addition to extension of remand work, also dispose off the Miscellaneous Applications listed for hearing through Video Conferencing.

Sh. Sunil Kumar (E.C. No. 13983) Judicial Assistant in furtherance of circular no. 7373-7376/Adm./DWK/Misc./2020 dated 10.05.2020, shall facilitate the Judicial officers for conducting remand proceedings from their respective residences.

Ms. Rosy Saxena (E.C. No. 2441) Senior Judicial Assistant shall look after the work of Sh. Sunil Kumar, Judicial Assistant in case of his non availability for any reason whatsoever.

Rest of the modalities shall remain same as per previous duty rosters.
