- The judicial officers including the District Judge (Commercial Court) shall be under the control of the District & Sessions Judges of the District to which they have been allocated.
- The judicial officers under transfer shall notify the cases in which they had reserved judgments orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.

- The Court of District Judge (Commercial Court) in New Delhi district to be presided over by Ms. Anju Bajaj Chandna is re-designated as District Judge (Commercial Court) 91, New Delhi, PHC.
- The Court of District Judge (Commercial Court) in South district being presided over by Mr. Ramesh Kumar-I is re-designated as District Judge (Commercial Court)-01. South,
- The Court of District Judge (Commercial Court) in South-East district being presided ever by Mr. Raj Kumar Chauhan is re-designated as District Judge (Commercial Court) 01, South-East, Saket.
- The Court of ADJ-05 New Delhi, PHC hitherto presided over by Mr. Praveen Ku nar stands abolished. The District and Sessions Judge shall allocate the cases of this court to other such Courts in the district to ensure equal pendency.
- The Courts of ADJ-11 and ADJ-12, Central, THC hitherto presided over by Mr. Marish Yaduvanshi and Mr. Sanjeev Kumar-I respectively stand abolished. The Distric & Sessions Judge shall allocate the cases pending in these Courts to other such Courts in the district to ensure equal pendency.
