Note: 1) Fresh cases which are **extremely urgent** in nature shall be accepted by the Facilitation Centre for listing only after the Advocate has contacted the Administrative Officer (Judl.) telephonically. The advocate shall speak to the Administrative Officer (Judl.) on phone and convey the extreme urgency involved. Only thereafter necessary instructions will be issued by the Administrative Officer (Judl.) to the Facilitation Centre for accepting the case.

- 2) The officers of DHJS & DJS rostered for extremely urgent will be available on call and shall have the liberty to attend to the matter in the Court premises or at his/her residence.
  - 3) For fresh matters of extreme urgency, Administrative Officer (Judicial) will contact



the rostered officers and seek his/her convenience for attending the matter in the court premises or at his / her residence.

- 4) The aforesaid officers shall be assisted by his/her own court staff. The officers shall depute the staff as per requirement and the officer shall depute only those staff officials who are residing in Delhi and are using own conveyance. In case of insufficiency or non-availability of staff in any of the aforesaid courts, the Administrative Officer (Judl.) shall ensure the staff for aforesaid court taking into consideration that only court staff residing in Delhi and using their own conveyance are called for duties.
- 5) Ms. Usha Khattar, Sr. A.O. (Judl.), Mob. No. 9891204839 & Ms. Manju Bindra, Sr.A.O (Judl.), Mob. No. 9910828209 have been nominated to be Administrative Officers for the period 24.03.2020 to 04.04.2020.
- 6) All those officers/officials who are not called for duties, shall remain available for duties on phone call and shall not leave the station, in any case.
- 7) In case of urgency or unavoidable circumstances, if the rostered Judicial Officer(s) is not able to perform his/her duty on the dates mentioned against his/her name then he/she shall take the willingness of other Judicial Officers and send the request letter to the office of undersigned for change of duty.
- 8) In view of order of Hon'ble High Court's notification number 373/Estt.E-I/DHC dated 23.03.2020, Lawyers' Chambers, (S W), Dwarka Courts shall remain closed.
