ORDER

In compliance of order no. 78-89/SCMSC/DHC/2023 dated 03.06.2023, issued by Hon'ble High Court of Delhi and in supersessions of earlier orders bearing no. D -39/CMM/SWD/DWK/New Delhi/2020 dated 15.06.2020, D- 43/DR/CMM/SWD/Dwk/New Delhi/2020 dated 24.06.2020, D -70/DR/CMM/SWD/Dwk/New Delhi/2020 dated 17.11.2020, and D – 3203-3247/CMM/S-WD/Dwk/New Delhi/2022 dated 21.07.2022, it is ordered that the allocations of fresh 138 NI Act cases be allocated as per procedure/table below (with immediate effect):-

1. All fresh 138 NI Act cases (financial institutions) be sent to the Ld. Magisterial Courts (Ld. MM -01, 138 NI Act to Ld. MM – 09 138 NI Act, Dwarka Courts & MCD Court) as per the following procedure/format (as per the institution/registration at facilitation center, Dwarka Courts) by the facilitation center, Dwarka Courts, without marking/assignment till further orders.

3. All fresh 138 NI Act cases (private parties) be sent to the Ld. Magisterial Courts (Ld. MM -01, 138 NI Act to Ld. MM – 09 138 NI Act, Dwarka Courts & MCD Court) as per the following procedure/format (as per the institution/registration at facilitation center, Dwarka Courts) by the facilitation center, Dwarka Courts, without marking/assignment till

further orders.
