All concerned Judicial officer/s are requested to direct their staff to retain the pending bail application/s with them during their roster tenure and direct them to do all necessary compliance in terms of the order passed in the bail application/s. However, the decided file/s be sent to the 'Facilitation Centre' on day-to day basis, positively by 04:00 p.m.
