ORDER

3. In case, the Judicial Officer/s whose name/s is/are mentioned in corresponding Column (D) is/are also not available, the bail work shall be looked after by the Judicial Officer/s whose name/s is/are mentioned immediately below in the Column (D), and so on.
4. All concerned Judicial officer/s are requested to direct their staff to retain the pending bail application/s with them during their roster tenure and direct them to do all necessary compliance in terms of the order passed in the bail application/s. However, the decided file/s be sent to the 'Facilitation Centre' on day-to day basis, positively by 04:00 p.m.
