The rest of the Terms & Conditions of the service will be intimated in due course.



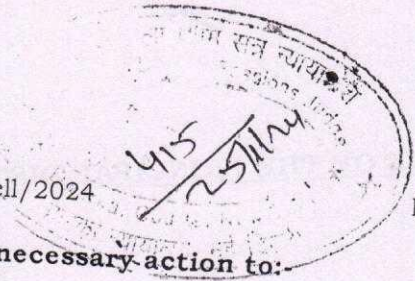
