

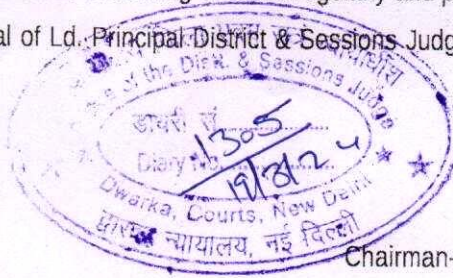
CIRCULAR
