- 4. Proof of being a bonafide Advocate:
  - a. Advocates with over 25 years of standing, Designated Senior Advocates, Former Judicial Officers, or Law Researchers engaged with the Hon'ble High Court will be considered bonafide based on the relevant document/identity card itself.
  - Advocates with at least 12 appearances before Courts in a year must provide self-attested and stamped copies of order sheets showing their names as lead or assisting counsel by 31<sup>st</sup> July, 2024.
  - c. Partners and Associates of registered Law Firms must furnish a certificate from the Equity Partner of the Law Firm along with proof of professional remuneration for at least six months.
