**NOTICE**

As per the schedule of election process circulated vide earlier notice dated 25<sup>th</sup> July, 2024 of this office, the 'Tentative Voter List' was slated to be published on 16-08-2024. However, owing to large volume of data and paucity of time and resources for processing the same, the exercise is taking longer than anticipated.

**Additionally**, during the initial review and scrutiny of the submitted declaration forms, various discrepancies have been observed, requiring further verification of the details provided by the Bar members. To ensure accuracy and integrity in the election process, additional information and data have been formally requested from relevant offices and authorities, including the Dwarka Court Bar Association. As this information is still awaited, the verification and scrutiny process will take more time.

Once the scrutiny and validation are complete, the **Tentative Voter List** will be published. This list will outline the discrepancies identified by the Election Committee and will be available for review. Members of the Bar will be invited to raise objections or request corrections regarding the details in the published list.

In the meantime, a **Preliminary List** of members who have submitted their Declaration Forms and have not yet withdrawn the same has been published and can be accessed on the website of District Courts, Dwarka.

In case any member discovers that their name is included in the Preliminary List despite not having submitted their Declaration Form personally or through an authorized representative, they may request the withdrawal or cancellation of the Declaration Form in writing. This request, including the reason for withdrawal, must be submitted by or before **21<sup>st</sup> August 2024**.

The Election Committee is dedicated to conducting a transparent and fair election process. Please stay alert for further notices with updates and instructions as we move towards finalizing the voter list.
