

Civil Jurisdiction:

In terms of the Notification bearing F.No. PS/[DIV.COM/Misc./2011/1948](#) dated 11.09.2012 issued by the Department of Revenue conveyed to this Office vide letter No. 1207-1216/DHC/Gaz./G-1/Judl.Distts/2013 dated 25.02.2013 of the Hon'ble High Court of Delhi, New Delhi, it was informed that in supersession of all earlier Notifications, the Lieutenant Governor of the National Capital Territory of Delhi has been pleased to create and form 11 Districts/Sessions, Divisions by altering and modifying the limits of the existing Sub-Divisions/Tehsils in Delhi. Each District/Sessions Division and the Sub-Division under the District shall be known by the name, as under:
