

Sir,

Vide orders dated 26.04.2018, Hon'ble the Acting Chief Justice has been pleased to order that the following instructions be issued to the Judicial Officers of all the Districts:

- (a) No staff attached to the Judicial Officer is permitted to delete or pull down orders/judgments once uploaded, without a judicial order being passed by the concerned Judicial Officer acknowledging the mistake and directing the mistake to be rectified.
- (b) The District & Sessions Judge In-Charge should specifically authorise the corrections to be carried out on the uploaded order/judgment under his supervision, by pulling down/ deleting the erroneous order and uploading the correct order/judgment.

You are requested accordingly.
