ORDER

Note:

2. All pending bail/urgent applications shall continue to be dealt with/heard and dispose of by the Court to whom such applications were initially assigned.

In case, the Judicial Officer/s whose name/s is/are mentioned in Column (C) is/are not available for any reason, then Judicial Officer/s whose name/s is/are mentioned in corresponding Column (D) shall deal/hear the bail application/s pertaining to the police stations/ investigating agencies mentioned against their names for any such day.
4. In case, the Judicial Officer/s whose name/s is/are mentioned in corresponding Column (D) is/are also not available, the bail work shall be looked after by the Judicial Officer/s whose name/s is/are mentioned immediately below in the Column (D), and so on.
5. All concerned Judicial officers are requested to direct their staff to retain the pending bail application/s with them during their roster tenure and direct them to do all necessary compliance in terms of the order passed in the bail application/s. However, the decided file/s be sent to the 'Facilitation Centre' on day-to day basis, positively by 04:00 p.m.

Bail application/s shall be heard strictly in terms of the above mentioned allocations.
