

- Three days Specialized Programmes for the Ministerial Staff of District Courts shall also be organized in every District of the State on the dates proposed by the respective Principal District & Sessions Judge (from April to December, 2024).
- All Programmes, except those conducted through online and other modes of telecommunication, shall be conducted offline at the venue. However, in case of exigencies, the offline programmes may also be conducted online and *vice versa* and the venue may also be changed as per the need.
- Orientation Training Course for the Judges of the District Judiciary, Short Term Training Programme for Judicial Officers nominated as Incharge Training for supervision of Field Training and Specialized Training Programme for District & Additional Sessions Judges (nominated as Visitor Judges) shall be conducted as per directions/requirement.
- Training in English language proficiency will be organized online for Judges of the district judiciary, covering a cluster of districts.
