

## High Court of Gujarat Launches SARAS: Remote Adjudication Courts for NI Act



a move to revolutionize the judicial system, the High Court of Gujarat inaugurated the Statewide Remote Adjudication Access System (SARAS) for cases under the Negotiable Instruments Act, 1881. The ceremony, held at the Gujarat High Court Auditorium, was graced by Hon'ble Mr. Justice Surya Kant, Judge of the Supreme Court of India, and Shri Bhupendrabhai Patel, Chief Minister of Gujarat. The initiative, led by Hon'ble Mrs. Justice Sunita Agarwal, Chief Justice of the Gujarat High Court, aims to address delays in

cheque bounce cases filed by banks and NBFCs in Ahmedabad City. These SARAS Remote Adjudication Courts will use VC, e-filing, and digital record management transform the justice delivery system. technology By leveraging optimizing judicial resources, SARAS ensures faster case disposals without requiring additional infrastructure. This initiative not only addresses arrears but also boosts iudicial by prioritizing economic growth timely resolution of commercial disputes.

# Launching of Internal Complaints Committee Portal of the High Court of Orissa



On 03.12.2024, the Hon'ble Shri Justice Chakradhari Sharan Singh, Chief Justice, High Court of Orissa launched the Internal Complaints Committee portal, in presence of Hon'ble Companion Judges of the High Court of Orissa. The Internal Complaints Committee portal is designed to facilitate the staff of the High Court of Orissa to lodge harassment grievances before the Committee for its consideration.

## E-Inauguration Of Digitization Project For District Judiciary Under Phase III Of E-Courts Project In Rajasthan High Court



Out of budgetary provision of Rs. 5.50 Crore for scanning digitization in High Court and courts of District Judiciary of Rajasthan for Financial Year 2024-25 under Phase III of eCourts Project, Department of Justice sanctioned Rs.1,37,50,000/- as first release. Scanning Digitization of judicial records in District Judiciary has been started initially in 8 District HQs of Jaipur Metro I, Jaipur Metro-II, Jodhpur Bikaner, Udaipur, Metro, Bharatpur and Ajmer Judgeships. After providing basic and logistic support, the "Project for Digitization

in District Courts" has been started above 8 District Headquarters after e-inauguration of the Chief Justice of Rajasthan High Court Hon'ble Mr. Justice Manindra Mohan Shrivastava on December 05, 2024 in virtual presence of Hon'ble Chairman and Members of Hon'ble Steering Committee and the District Judges of **Project** Monitoring Rajasthan. Committees have been constituted at above District Judgeships Committee to ensure quality as well as timely completion of the work of scanning & digitization of judicial records.

## Wi-Fi Enablement of the High Court of Tripura Premises



The entire High Court of Tripura premises has been Wi-Fi enabled by setting up Wi-Fi access points in appropriate places. All the five Court rooms as well as the Bar building

have been enabled with high speed internet Wi-Fi facility which would provide easy and convenient internet access to all the stakeholders.

## Inauguration of Evening Court for Traffic Challans in Rouse Avenue District Court of Delhi High Court



The Hon'ble Mr. Justice Manmoan, Judge, Supreme Court of India had inaugurated "Evening Court Traffic Challans (ECTC)" on 20.12.2024. The aforesaid ECTC has a module which addresses the ever-mounting backlog of pending traffic challans. It

provides a user-friendly platform for violators to search and download their challans for disposal. This initiative expects to enhance the efficiency of the judicial process and provide timely resolution for traffic challans.




## Impact & Outcomes of the training:

#### MESSAGE

It is my pleasure to be a part of the Committee, dealing with the computerization of the High Court and District Judiciary, during this crucial transition period of Courts on to Digital Platforms.

The High Court of Andhra Pradesh continued its digital journey, after its bifurcation from the common High Court, in spite of initial hiccups and the intervention of the Covid-19 pandemic. Information Technology took a new dimension in this High Court starting from providing High-end Laptops and LaserJet Printers to the Judicial Officers for their Home Office use, apart from internet connectivity. The High Court not only replaced all the Servers in all the Court Complexes in Andhra Pradesh, but also provided Computers and Four Printers to each Court Room with the funds sanctioned under Phase-II of eCourts Project together with State Government funds. The High Court of Andhra Pradesh also provided Hi-end Computer Hardware and Internet Connectivity with redundancy to the Judges working in the High Court.

The High Court launched IGJS and NSTEP effectively to serve summons in Civil Cases across the State and is now making the ground ready to extend the service of summons module to Criminal Cases. The High Court of Andhra Pradesh developed Online e-filling module during the Covid-19 pandemic and provided virtual hearing as an exemplar to the rest of the Country.

The digital journey which started in the pandemic changed the face of the Andhra Pradesh Judiciary in the new digital era, and accelerated its speed during Phase III of eCourts Project. The High Court of Andhra Pradesh not only procured the required Computer Hardware as per the sanction of the Hon'ble eCommittee, Supreme Court of India, but also started its e-Initiatives on par with the other High Courts in India.

The High Court of Andhra Pradesh initiated several projects traveling towards digital environment with more emphasis on efficiency and transparency. All the District Courts Websites have migrated to S3WaaS Platform and all the Court Establishments in the Andhra Pradesh have migrated to CIS 4.0 version.

The High Court started digitization of judicial records in the High Court and District Judiciary, starting a new journey towards Digital Courts. The High Court of Andhra Pradesh has been planning to release a new dynamic website with all new e-Services on the best User Interface Platform.

The High Court of Andhra Pradesh also started using futuristic technology in judicial domain viz., Artificial intelligence on "Adalat.Al" Pietform for dictating orders, recording evidence, etc., and for translation of judgments while using "Suvas" and 'Anuvadini' Al Tools. The aim of the High Court in adopting the Al Tools is to expedite the litigation to the expectations of the common man in the Country.

The High Court of Andhra Pradesh is looking forward towards e-Filing and Paperiess Courts and also for providing services to the stakeholders by establishing 38 e-Sews Kendras in the High Court and District Judiciary.

The High Court of Andhra Pradesh is dedicated to extend its e-Services to all the stakeholders ensuring speedy justice.

# Achievements of the Phase I and Phase II of e-Courts Project of the High Court of Andhra Pradesh

### Phase I of eCourts Project:

### Provision of Laptops and Printers:

The Judicial Officers of the State of Andhra Pradesh were provided with Laptops to work efficiently from the Home Office. The Judicial Officers were also provided with LaserJet Printers at the home office, to enable them to take the print-outs of any urgent Orders/Judgments at their residence.

Judicial Service Centers: Judicial Service Centers were opened at all the Court Complexes enabling the Advocates and Litigants to have their Case Information across the counter.

Court Complexes Infrastructure: All the Court Complexes were equipped with servers to store and manage the case data of the CIS software and to push the same to the NJDG.

Court Complexes in the State of

Andhra Pradesh were provided with Desktop Computers and LaserJet Printers to access CIS Software and also to take the print-outs of the Judgments, Orders, etc., respectively.

Internet Connectivity: All the Court Complexes and Courtrooms were provided with broadband internet connectivity for uploading CIS data to the NJDG. All the Judicial Officers were provided with Internet connectivity with a specific plan at their Home Office enabling them to browse the Online Law Journals, Official Websites.

Power Backup Systems: Diesel Generator sets and UPS Systems were installed in all the Court Complexes to function with the ICT Hardware and save the data in the Computers during the power interruption.

Extensive **Training Programme:** Training Programmes were conducted for the Judicial Officers Ubuntu-cum-CIS through Ubuntu Master Trainers (Judicial Officers) and also for the Court staff through the District System Administrators on the usage of the Hardware, Ubuntu Computer Operating System, CIS Software, etc., and ensuring the transmission of Judicial System into a Digital System for smooth functioning of the Courts.

Technical Manpower: Technical Manpower was deployed in all the Districts by recruiting them in the cadre of System Officers and System Assistants to oversee the total eCourts Projects and it has been successfully implemented.

## Phase II of eCourts Project: Introduction of ICJS and NSTEP:

The High Court has implemented the Interoperable Criminal Justice System (ICJS) and National Service and Tracking of Electronic Processes (NSTEP) across the State. The High Court enabled the electronic process of filing and receiving Police Reports and also of service of summons in Civil Cases. The High Court made appropriate amendments to the Civil Rules of Practice to accommodate the service of process through NSTEP. The High Court procured 1872 numbers of Handheld Devices (Mobile Phones) and supplied them to the Process Servers and Field Assistants with data recharging to serve the summons and execute the process using the NSTEP Module.

Video Conferencing: The High Court started hearing cases through Virtual/Hybrid mode during the COVID-19 pandemic and continued the same. The High Court of Andhra Pradesh also notified VC Rules to hold virtual court proceedings and recording of evidence to further enhance accessibility.

Kiosk **Machines:** the As per of initiatives the Hon'ble eCommittee, Supreme Court of India, the High Court provided Kiosk Machines in all the Court Complexes across the State enabling the parties to have the Case Information System (CIS) through Kiosk Machines.

**Installation of Justice Clock:** As per the instructions of the Hon'ble Supreme Court eCommittee, India, the High Court took steps for the installation of a Justice Clock in the High Court premises digitising case information including the case status of institutions, pendency and disposals. The High Court also designed and developed a web application to display the case status on the official website.

Master Trainers, Staff and Advocates Training: The High Court identified certain Judicial Officers as Master Trainers under the able guidance of the Hon'ble eCommittee,

Supreme Court of India and also identified certain Court Staff who received comprehensive training on eCourts Project and other service modules. The Master **Trainers** (Judicial Officers) and other members training the other imparted to Officers, **Judicial** Court Staff, Advocates and also Advocate Clerks across the State.

Solar Power Installation: The High Court also took steps for the installation of Rooftop Solar Systems in Court Complexes during Phase-II of the eCourts Project as a part of the green energy initiative.

Online RTI Portal: The High Court also designed and developed an online RTI Portal under the Right to Information Act, 2005 and took steps for development of similar portals for the District Courts across the State enabling citizens to file RTI electronically.



### Digitization of Court Records:

The High Court of Judicature for the State of Telangana and for the State of Andhra Pradesh took the initiative for the Digitization of High Court records during the High common Court and completed the process with Digitization of judicial records to a certain extent and later took initiative for Digitization of Court records in Andhra Pradesh in Phase-III of the eCourts Project.

#### Collaboration with State Police:


The High Court had periodical meetings with the Police Departments to ensure the smooth integration of ICJS in the Judicial Process.

Hardware: The High Court provided new servers to all the Court Complexes in the District Judiciary for the State of Andhra Pradesh and also provided two (2) rack servers to the High Court. The High Court also took steps to provide two (2) desktop computers

and four (4) printers to all the Court Establishments in the State of Andhra Pradesh with the unspent funds of Phase-II of the eCourts Project and also meet the remaining budget from the State Government funds. All the Court Complexes in the State of Andhra Pradesh will be equipped with new Servers with advanced technology

and also equipped with Six (6) numbers of Desktop computers and four (4) printers in each courtroom by the end of the Phase-II of the eCourts Project.

eVisitor Pass System: The High Court introduced the ePass System by developing an Application viz., ePass to provide the pass in an electronic mode to the visitors of the High Court.



## Ongoing Phase III of eCourts Project at the High Court of Andhra Pradesh

Computer Infrastructure: The High Court provided four (4) all-in-one all the computers Court to Establishments under covered Phase-II of the eCourts Project during the 1st Financial Year 2023-24 of Phase-III of the eCourts Project. The High Court also provided extra Nodes to all the Court LAN establishments.

Exploration of AI Tools: The High Court of Andhra Pradesh started exploring AI Tools, initially for the translation of Judgments from English to Regional Language by using SUVAS, Anuvadini, etc. The High Court also started using the dictation tool for dictating the Orders/Judgments, recording evidence and translation as well.

Capacity Building: The High Court has been successfully implementing the training programmes under the component of Capacity Building to provide extensive training to the Officers, **Judicial** Court Staff, Advocates and Advocate Clerks. These training programmes being conducted with the help of the APSJA and the Master Trainers (Judicial Officers), Advocate Master Trainers, District System Administrators, System Officers and System Assistants.

## Best Practices (e-Initiatives) of the High Court of Andhra Pradesh



Digitization: The High Court of Andhra Pradesh initiated the process of scanning and digitization of records in the High Court with in-house manpower by engaging 50 persons through the State Nodal Agency and procuring the hardware components such as all-in-one Desktop Computers with the funds released under Phase-III of the eCourts Project, scanners and other hardware equipments with the State Government budget. The High Court also started the process of scanning and digitization of judicial records

beginning at Chittoor District on a Pilot basis and later, it extended the Work Order to the other Districts Ananthapuramu, viz., Kadapa, Kurnool, Prakasam, Guntur, West Godavari, Srikakulam and Vizianagaram. The High Court is going to commence the process of scanning and digitization of judicial records the very at soon Headquarters of Visakhapatnam, East Godavari and Nellore.

**SMS Alert System:** The robust SMS system has been introduced to Advocates about the status of the

case filing, scrutiny and registration the system also provides timely updates of cases enabling the Advocates to know the status as to listing of their cases before the Bench concerned.

Display Boards: The High Court procured and provided 50 numbers of display boards and 55-inch Display Boards across the High Court and also at key locations, such as the Bar Association, Government Pleaders Office, Library and Canteen, etc. These boards display the real-time case hearing status.

**Technical Manpower:** The High Court engaged four (4) Senior

Software Programmers and one retired NIC Personnel with funds from the State government and started the development of its own Software Applications to suit the convenience of the High Court as well as the District Judiciary.

Paperless Meetings: The High developed Court a software application viz., Meetings e-Scheduler enabling the Registry to supply digital copies of the meeting materials to all the Committee Judges enabling them to read the same over electronic devices and participate in the meetings by dispensing the paper materials.



Computer Hardware to the High Court Judges: The High Court also provided one iMac all-in-one Desktop Computer, one Laptop/Microsoft Surface Pro and one iPad enabling the Judges to have virtual hearings and read the judicial as well as administrative records.

Virtual and Hybrid Hearing High Court and System: The District Judiciary under the control of the High Court have been conducting the Virtual and Hybrid hearings of the cases as per the directions of the Hon'ble Supreme Court of India in Sarvesh Mathur's case. The High Court initially used the BlueJeans Software Application for virtual and hybrid hearings and later migrated to the Microsoft Teams Software Application which is user-friendly and easy to access. The High Court also developed a software Application to know the

and in hybrid mode. The High Court also provided the VC links in the Live status of Cause List and on a separate module called VC links. The High Court has been maintaining a static notification on the Official Website providing all the meeting IDs, passcodes and links of Benches showing the status as 'Active' or 'On leave'.

eFiling: The High Court started implementing eFiling 3.0 on a pilot basis in Criminal cases, such as Bail Petitions, Criminal RCs, Criminal Appeals, etc., with an off-line Court Fee module.

eSewa Kendras: The High Court took the decision to establish four (4) eSewa Kendras at the High Court and thirty-four (34) eSewa Kendras at the District Court Complexes where there are more than ten (10) Courts. All the eSeva Kendras will be provided with

all-in-one computers, scanners, document visualizers, cameras, microphone-cum-Speakers and manpower as recommended by the Hon'ble eCommittee, Supreme Court of India.

Internet and Wi-Fi facilities: The High Court has 1 Gbps ILL (internet internet leased line) connectivity from M/s. Powergrid Teleservices with redundancy of 1 Gbps ILL Internet connectivity from M/s. BSNL. The High Court is equipped with 155 Access Points across the High Court to provide Wi-Fi facilities free of cost to all the Advocates, Staff and other visitors who attend the High Court. Paperless Courts: The High Court of Andhra Pradesh introduced Paperless Courts starting in Court Hall No. 3 on a Pilot basis by developing an in-house software The application. application provides access to the Hon'ble

Judges, Advocates/ Parties-in-Person, Court Officers/Court and Personal Secretaries/Court Masters on log-in basis. Once the case scanned and digitized a platform of 'Scanning and Digitization', the digital copies of records will be accessed through the Paperless Courts Application providing an electronic platform to all the stakeholders dealing with the cases. The Judges have access to the case files electronically at the Court Office as well as the Home Office. The circulation of physical files to the residence of the Judge/s is successfully dispensed saving manpower and fuel and also environmental pollution. Similarly, the Advocates with their code can log-in into the application and can have access to their The only. cases Advocates/Parties-in-Person who

do not have the electronic device can access the Court records through the Court log-in and the Court Officers can mention the next date of the posting in a test box designed in the Application. The movement the matter is reserved for Orders/Judgments, the

file will automatically be sent to the Personal Secretary/Court Master on a single click. This robust Application enables all the stakeholders dealing with the records to work in a Paperless environment on the Neo Digital Courts platform.



Digi-APLR: The High Court of Andhra Pradesh took steps for the development of a portal for publishing reportable Judgments of the High Court with head-notes and search facilities in digital formats. The Digi-APLR Portal is the Official Law Reporter of the High Court published in Fortnightly and consists of four (4) parts to each volume. The Parts and Volumes are automatically

depending upon the generated number of pages assigned to each Part and each Volume with a beautiful cover page. The Neutral Citation is also being fetched from the Neutral Citation Portal automatically as an equivalent citation to the APLR Citation. If there are translated copies of the Judgments of the High Court maintaining eAPHCR, they are automatically fetched the to Digi-APLR Portal. The Digi-APLR also consists of Split View, HTML View, Flip View and PDF View in Telugu as well as English. It also enables the search fields by Party Name, Case Type, Date Judgment, Coram, Advocate Name, Neutral Citation, APLR Citation and KeyWord. The Keyword option is enabled for all the words in the Judgment.

**eAPHCR:** The High Court of Andhra Pradesh also took steps to

develop one more application for maintaining the database for the **Judgments** translated of Supreme Court of India as well as the High Court of Andhra Pradesh. This application is being developed and maintained as per the instructions of the Hon'ble Translation AI-Assisted Legal Committee, Advisorv Supreme Court of India. The front-end view is provided to have access to this Application from the new Official Website of the High Court in a robust manner.

Neutral Citation: The High Court implemented the Neutral Citation search module. Initially, the High Court received the Source Code of the Application from the High Court of Kerala and further, it developed the same by creating several search options like search by Party Name, Case Number, Date of Judgment, Coram, and Neutral

Citation and a robust front view is also provided to the users.

Online CD Application: The High Court of Andhra Pradesh has taken steps to develop an online CD Application for providing certified copies of interim and final orders respective parties to advocates entitled to them, upon payment of the requisite fee online. Once an application is filed and payment is made through the acknowledgment is portal, an generated confirming the payment. Subsequently, the certified copy, along with a facing sheet digitally signed by the concerned Section Officer, is sent to the account of This application the advocate. complies with the directions of the Hon'ble Supreme Court of India in Harsh Bhuwalka & Ors. vs. Sanjay Bajoria Kumar (Special Leave Petition [Criminal] No. 30456/2024). The High Court is also taking steps

to extend the application to the District Judiciary, following the inclusion of the High Court in the Wide Area Network (WAN) and the integration of the District Court database into the High Court servers. This integrated system is envisioned to be termed the 'State Judicial Data Grid' in the future.

Juvenile Justice: The Hon'ble the Chief Justice of the High Court pleased to constitute was Committee to monitor the matters relating to Juvenile Justice for which the High Court developed a Portal to maintain the objectives, and Rules, Guidelines, Acts Orders, Schemes Circular Children, Important Judgments, numbers telephone of the concerned and also Photo/Video Gallery.

Accessibility: The Hon'ble Chief Justice constituted a Committee to address matters related to

differently-abled persons, for which High Court developed application named Accessibility. The application features inspiring stories of renowned differently abled Indians on its home page. It also includes details about Accessibility Committees in the High Court and District Judiciary, the Standard Operating Procedures provided by the Hon'ble Supreme Court of India, minutes of meetings, key laws and reports, and significant judgments. Additionally, a portal has been created to allow individuals to submit grievances related to accessibility. Once a grievance is raised, it is promptly directed to the concerned person, and updates are provided after the grievance is addressed. The portal is also designed to incorporate future features, such as UNO conventions and a photo gallery.

**Judges Dashboard:** The High Court has developed an application to

Judges with provide access to comprehensive information on platform. single Through application, Judges can Paperless Courts, Committees, Cause lists, Rosters, Notices, the Telephone Directory, Casual Leave records, Reportable Judgments, Published Judgments, Final Orders, Interim Orders, and Court Proceedings dashboard. directly from the Additionally, Judges can access Digital Law Reporters and obtain information about meetings, including meeting materials and minutes. The application also provides administrative Judges with access to relevant statistics.

Management System (CIMS): The High Court took steps to develop one more Software solution for the management of the Computer infrastructure in the High Court as well as the District Judiciary. This is

an electronic platform that enables the Registry officers as well as the staff members in the District Court to have comprehensive information regarding the software and hardware components available in the High Court and District Judiciary, at a glance. This made the job of the Registry easy to know the status of the software and hardware components in the High Court as well as District Judiciary.

Officers Law **Standing** and The High Court also Counsels: developed two more **Portals** maintaining the information relating Law Officers and Standing Counsels appointed by the State as well as Central Governments. These platforms first-hand provide information to the Advocates and other stakeholders to know the names and other details of the Law Officers as well as the Standing Counsels dealing with particular

subjects and also departments enabling them to serve the notices quickly.

**STAT-HUB:** The High Court took steps for the development of one more robust Application to get the statistics from the District Judiciary by dispensing the paper statements. The trial Courts can simply fill the institutions and disposal columns and submit the statements to the Principal District Courts concerned. The Principal District Courts can simply collect the same automatically on a single platform and submit the same to the High Court. The High Court can access the statements within no time and the Registry has been using the said platform to provide the basic information regarding institutions pendency, and disposals of the cases in every



District. The High Court has been giving a link by providing the statistics on the Official Website of the High Court. At the same time, the statistics of the concerned District are integrated into one more software Application developed by the High Court for Hon'ble Judges viz., Judges Dash Board enabling the Administrative Judges to access the statistics directly.

Judicial Officers eCorner: The High Court has taken steps to develop a unified platform viz., Judicial Officers eCorner, to manage all

matters related to Judicial Officers working in the District Judiciary. This is a login-based application that allows Judicial Officers to share their official, personal, and family details, including property information, in compliance with State Rules. Through this application, Judicial Officers can apply for leave and various permissions, such as property-related permissions, higher education permissions, visa permissions, and passport The platform permissions. includes a legal chat feature and a mailing system. It is a user-based

providing tailored application, information based on the type of ensures that user, and **Judicial** Officers receive timely approvals for leave or other permissions from the The application will High Court. also be extended to facilitate the submission of Annual Confidential Reports (ACRs) to the High Court, maintaining these records securely in a database to prevent loss. It will further include features for handling complaints and inquiries, work reviews, ACR management, and the maintenance of service registers. Judicial Officers eCorner aims to serve as a single platform for all service-related matters of Judicial Officers. Developed with forward-looking approach, it designed to integrate with DC CIS 4.0 to display data such as the disposal of 5-year-old cases, case institutions, disposals, and pending statuses at the level of individual

officers, districts, or the entire state, depending on the user type. Additionally, the platform provides information about the personal skills of Judicial Officers, including languages known and any health issues, creating a comprehensive digital solution to meet all the needs of Judicial Officers.

Court Complex Infrastructure: The High Court also took steps to develop one more Application to submit and access the Complex information regarding the available in each Complex, the constructed area and other amenities available in the Court Complex. Such information from every Court Complex will be submitted to the Principal District Courts and in turn, it will be sent to the High Court in the Portal. The High Court as well as the District Judiciary can access the data on the user base.

### **New Dynamic Website:**



The High Court also developed a new dynamic official Website for the High Court of Andhra Pradesh and a beta version was also released on 01.01.2025. Various Applications developed by the High Court are being integrated and will be hosted from the NIC Data Center, Hyderabad, the State Data Center and the High Court Servers.

**District Court Websites:** All the District Court Websites were

migrated to the S3WaaS platform according to GIGM (Guidelines of Indian Government Websites) to ensure security, transparency, accessibility and seamless information to the public. The District Courts websites are completely accessible to differently abled persons and all the links of the websites of the District Courts are provided in the Official website of the High Court.


CIS 4.0: The High Court of Andhra Pradesh took steps for the migration of CIS software provided to the District Judiciary from DC CIS 3.2 to DC CIS 4.0. This task might have been completed as the first biggest State in the Country.

Storage Area Network (SAN): The High Court procured SAN of 47 TB of usable space and installed it at the High Court in the first instance and decided to extend the storage up to 164 TB of usable space. The High Court also procured one more SAN device to be installed in the State Data Center and also decided to extend the storage of SAN device up to 164TB and also to port the data from the High Court to the State Data Center through P2P connectivity to make sure that the

public can access data stored in the State Data Center.

**Phase-III Components:** The High Court has been procuring all the components allotted in Phase-III of the eCourts Project including ICT Hardware provided to the High Court with NAS storage of 500 TB space and also usable components for Paperless Courts and Live Streaming. However, the purchase process is in progress and the High Court will strive to complete the process by the end of this Financial Year 2024-25. The High Court of Andhra Pradesh has been making endless efforts to stand on the Neo Digital Platform serving the people with timely with iustice more accuracy, efficiency and transparency.

Though Video Conferencing facility was already available, however in March, 2024, the facility of Hybrid Video Conferencing Hearing has been made operational for the High Court and all Courts spread over 123 Court complexes in 45 Districts in States of Punjab, Haryana and UT Chandigarh. Our mission is to benefit all stakeholders by providing transparent, fast, and efficient litigant centric services.

# Achievements of the Phase I and Phase II of e-Courts Project of the High Court of Punjab & Haryana

Computerization of Courts: Under Phase I, 689 courts were successfully computerized to improve digital infrastructure in the judiciary. **Judicial** Service Additionally, 41 Centres and Computer Server Rooms were established to support court operations. Essential hardware, 500 VA UPS. printers, scanners, hard drives, projectors, servers, cables, and DG Sets are provided to enhance court functionalities and digital access.

Video Conferencing in Jails and Courts: Video conferencing (VC) facilities are introduced in 15 jails and 19 courts to enable remote hearings.

Local Area Network (LAN): A total of 5,829 LAN points were installed in courtrooms across Punjab, Haryana, and Chandigarh. This ensured seamless connectivity for court

operations and digital case management systems.

Connectivity Setup by e-Committee: To strengthen communication, 103 sites are connected via a Virtual Private Network over Broadband and 35 sites are linked through NICNET Lease Lines.

State-Provided Connectivity: State governments contributed by connecting 56 sites in Punjab through the PAWAN network and 10 sites in Haryana through the SWAN network.

Technical Manpower: During the e-Courts Phase II Project, Technical Officials were deputed to this Court. Funds provided for Technical Manpower under the e-Courts Phase II Project were utilized for payment of salaries of the aforesaid employees.

# Ongoing Phase III of eCourts Project at the High Court of Punjab & Haryana

For the Financial Year 2023-2024, under the e-Courts Phase III Project, the Hon'ble e-Committee, Supreme Court of India, provisioned funds for various hardware items including technical desktops, scanners, manpower, and capacity building. Specifically, funds were allocated for 1,654 desktops and 1,057 scanners. A considerable amount was provisioned for technical manpower and capacity building. Funds described above were used in the following matter:-

• Scanners:-1247 units of Scanners

were purchased out of the aforesaid funds.

- **Desktop:**-1828 units of All-in-One Computers were purchased out of the aforesaid funds.
  - Technical Manpower:- During FY 2023-24, sufficient funds were already available with the Punjab and Haryana High Court to pay salaries of Technical Manpower deputed by the Punjab and Haryana High Court.
- Capacity Building:- Funds were transferred to Chandigarh Judicial Academy.

## Best Practices (e-Initiatives) of the High Court of Punjab & Haryana

Digitization of Judicial Records in the High Court: The process of Scanning and Digitization in the Punjab and Haryana High Court was initially started in the year 2012 and was completed in the year 2018. As of date scanning of freshly instituted cases and of incremental being done filing is High-Speed Scanners installed in the filing section as well as in respective judicial branches. The scanning of Administrative files is also done by concerned branches at their own level.

District Judiciary: The scanning and digitization of judicial records are ongoing in all District Courts of Punjab, Haryana, and Chandigarh. Till 30.06.2024, approx. 50.66 crore pages of Judicial and Administrative

records have been scanned in District Courts. Scanning of fresh cases in all the District Courts has also been made mandatory w.e.f. 01.06.2022. Till 30.06.2024, approx. 4.38 crore pages of Judicial records of fresh cases have been scanned in District Courts.

**Document Management Systems** (DMS) upgradation for District Courts:- Document Management Systems (DMS) - Dspace has been upgraded from version 5.6 to 7. The DSpace 7 brings about significant enhancements, including an improved user interface, tightened security, and enhanced scalability. The updated version of DMS has been installed and implemented at all the District Courts in the States Punjab, Haryana and U.T. Chandigarh.

e-Diary Module: e-DIARY, a case management system for the use of Advocates and government departments has been helping them in managing their cases through the website of the Punjab and Haryana High Court. They can view the e-case diary of all the cases filed by them and the cases in which they are representing one of the parties. They have also been provided with the facility to view all the cases fixed for various dates, at a glance. In order maintain to complete confidentiality, limited access to the system has been provided to the Advocates, after users' authentication. This facility has been extended to AG Offices, State State Governments, and Universities.

PHHC Mobile Application: The PHHC Mobile application, developed by the NIC High Court team, provides all the information

available on the website of the Punjab and Haryana High Court (phhc.gov.in), with the convenience of a mobile app.

Library Automation with book scanner and RFID system: The High Court Judges' Library houses approximately 1,77,526 books weeded-out (including and written-off books) and utilizes KOHA Library Automation Software for housekeeping operations. New arrivals of books and journals are regularly updated in the KOHA system. Following the Supreme Court's instructions, **KOHA** Library Management Software has been installed in all High Court Libraries. The library has also implemented RFID (Radio Identification) Frequency technology integrated with KOHA, which facilitates the automatic issuing and returning of books. Additionally, a Book Eye 4 (Basic)

scanner has been installed in the Judges' Library. This scanner is used for scanning books, gazettes, and prestigious projects involving rare or old books available in the library. Scanning is also done upon the request of the Hon'ble Judges of the Court.

**Surety Information Management** Information **System:** Surety Management System contains vital information like UIDAI Number, DOB, a real-time photograph of surety and verifier captured in the Court. This software has been integrated with Case Information System (CIS) resulting in the linkage of case details with surety details. This amalgamation will help in the identification of defaulters giving sureties at multiple places with bogus identities. It includes online verification and easy online record maintenance.

Online Recruitment: To enhance

transparency and efficiency, the recruitment process for High Court and District Court employees has transitioned to an online system. Candidates can register on the web portal, upload their photographs and documents, and pay the application fee online. Both the Computer Based Test (CBT) and the subjective paper examination are conducted online. The entire evaluation process is managed online, with the project being outsourced to Tata Consultancy Services.

Personnel Information System (PIS): The Personnel Information System (PIS) has been developed for judicial officers in Punjab, Haryana, and Chandigarh, allowing them to view their service-related records, including ACR, property details, leave records, transfer, and salary details. It offers comprehensive search queries and even provides

automated birthday greetings. This revised information covers the digitization efforts and various technological advancements in the judicial system, using simple English sentences and in the third person perspective.

E-Statement Software for District Courts: An e-Statement Software has been developed to help the High Crystal Reports Software for CIS (CCR): CCR 3.0 is a Crystal Reports Software for CIS 3.0 which has modules for generating many reports from CIS 3.0 like as Peshi undated/unregistered Register, cases, Order uploaded and not uploaded reports, auto generated Cause list, Cause list between two dates, Unregistered Cases Report, RBT cases Report, undated Cases, engineering Module, Unregistered Cases, Allocation of the case, Disposal Total cases report, Pendency, Case type wise Pendency, Courts access monthly statements and data from District Courts. This software is now operational in 19 District and Sessions Divisions and will be fully implemented in phases. The development of this software has saved huge amounts of paper by providing immediate access to data and has reduced the burden on the Court Staff.

Disposal Detail with final judgments/orders, Filing Counter Report Date wise etc.

#### **Description of Modules in CCR:**

- Engineer Module: Used for checking undated and unregistered cases.
- Order Template: CCR generates automatically ordered templates for each case in CIS.
- Peshi Register: Used for generating Peshi Register in CIS.
- Undated Cases: Used for checking undated cases with case details in CIS.

- Unallocated Cases: Used for generating unallocated cases in CIS.
- Unregistered Cases: Used for generating unregistered Cases with case details in CIS.
- Transfer Cases: Used for generating transfer cases court-wise in CIS.
- Total Pendency: Used for generating total pendency reports in CIS.
- Filing Counter: Used for generating reports of fresh cases in the filing Counter.

e-Custody Module: The e-Custody Module was launched in the year 2017 in the State of Haryana with the consultation of the High Court. This module helped to manage online custody certificates from different States, for the production of Courts, thus saving time and money for officials. It is presently implemented in the States of Haryana and Punjab.

e-Vetting: e-Vetting was launched

in the year 2017 in the State of Haryana, in consultation with the High Court. This module helped to facilitate officials concerned to get their reply or affidavit vetted from the Advocate General's office online. It eliminates the physical movement of files and manpower thereby saving huge resources and efforts.

LCR eCopy: The entire case record of District Courts is received in digital form, for appellate/revisional purposes thus, saving time and paper.

Digitized Agenda: Administrative files and agendas for Committee and Full Court meetings are digitized and circulated digitally at the High Court to enhance efficiency and reduce paper use.

Paperless Court in Punjab and Haryana High Court: The first step in setting up paperless courts was taken in the year 2014 when the

Android Mobile Application: A Mobile Application was developed during the COVID-19 pandemic for the court staff conducting VC wherein they have the facility to

Advocates have the option to upload

case files, and Court staff can

check the VC Cause List. This application saves the contacts of concerned counsel with a single click and also forwards WhatsApp messages regarding VC meeting ID and calls to the concerned counsel about participation in Court hearings through VC.

Judge's Diary Module: The facility of e-Diary has been extended to all the Hon'ble Judges of Punjab and Haryana High Court wherein they can download paper books of all the cases without using VPN. It also facilitated Hon'ble Judges to deal with cases from camp offices digitally through VC.

Video conferencing and Hybrid mode of hearing: The Punjab and Haryana High Court and all District Courts in Punjab, Haryana, and U.T. Chandigarh has video conferencing facilities. Dedicated video conferencing rooms with IP facilities are available in all court

complexes. The Punjab and Haryana High Court approved the video conferencing rules on 12.12.2020, and these rules are now part of the High Court Rules and Orders. The High Court and District Courts use NICMEET, Webex, JIOMeet, and free software for video other conferencing. All courtrooms are now equipped with hybrid video conferencing solutions. This extensive use of video conferencing has resulted in significant cost which would savings, have otherwise been incurred for the physical production of undertrials and doctors in court.

Public Wi-Fi: Pursuant to the directions of the Supreme Court of India in the matter of Sarvesh Mathur vs. The Registrar General, Punjab & Haryana High Court, the work of implementation of free Public Wi-fi in the premises of the Punjab and Haryana High Court has been

completed and the same is running successfully.

e-Filing: The e-filing rules have been adopted and are now included in the High Court Rules and Orders. Since 23.02.2024, e-filing 3.0 has been implemented in the High Court, as well as in District Courts across Punjab, Haryana, and U.T. Chandigarh. In Punjab and Haryana e-filing is also High Court, compulsory for Learned Advocates and individuals representing (Party-in-Person) themselves specific such as matters writ petitions related to the Land Revenue Act, tax matters, arbitration petitions under Section of Arbitration 11 the and Conciliation Act. commercial disputes, and writ petitions under the SARFAESI Act (Division Bench). implementation Adoption, and utilization of FASTER: The FASTER system for receiving the

communication from Hon'ble Supreme Court has been implemented and rules have been incorporated in the High Court Rules and Orders in this regard. A nodal officer has been appointed, and communications are carried out through this secure platform, with separate login IDs for each district.

Interoperable Criminal **Justice** (ICJS): ICJS **System** has been implemented in the States Punjab, Haryana, and Chandigarh. It aims to integrate the CCTNS System with eCourt, ePrison, eForensics, eProsecution, Fingerprint and Women & Child Department (WCD) systems for a seamless flow of information among these pillars of the Criminal Justice System to achieve "One Data Once Entry".

Virtual Courts: Virtual Courts have been launched at Faridabad and Chandigarh to deal with traffic challan cases in the entire State of Haryana. It is aimed at eliminating the presence of litigants in the Court and adjudication of the case online. The process for implementation of Virtual Courts for the State of Punjab is under active consideration.

e-payment mechanism: An e-payment mechanism has been implemented in the High Court and the District Courts in the States of and Punjab, U.T. Haryana Approximately Chandigarh. 84.77 crores have been transacted through this mechanism. The ePay portal is integrated with the Online Receipts Portal, with Stock Holding of India Ltd. Corporation authorized for Puniab and for Chandigarh, and e-GRAS Haryana.

e-Sewa Kendra:\_e-Sewa Kendra has been working in the premises of the Punjab and Haryana High Court

Since July 2020 as one Judicial Assistant from the Court establishment has been deputed to provide information regarding various e-Court services to the advocates, litigants and the public. e-Sewa Kendra is working at 108 sites out of 123 Court Complexes. Public Works The Department (PWD) of Punjab and Haryana has been requested to provide cost estimates for setting up porta cabins for e-Sewa Kendra at 76 court complexes.

YouTube Channel: A YouTube Channel of Punjab and Haryana High Court has been created under the name "High Court of Punjab and Haryana—Official" so that videos, inaugural webinars. functions, information material, streaming of oath ceremonies of Judges of the Punjab and Haryana High Court, Awareness and Training Videos etc. can be uploaded for the awareness of litigants and the general public. In this context, informative videos on various topics such as Paperless Steps Court, to access Case Information from the Website of Punjab and Haryana High Court, Steps to access Case Information from the Website of District Courts Punjab, Haryana and U.T. Chandigarh, etc. have been uploaded on said channel.

Chandigarh has been launched to facilitate online RTI applications and payments. The portal was

launched by the Hon'ble Chief Justice on 21.09.2023.

Training: Under the aegis of e-Committee, Hon'ble Supreme Court of India, 15 Training Programmes have been conducted for the Judicial Officer Master Trainers, newly appointed Judicial Officers, District System Administrators, Court Staff, Advocate Master **Trainers** and Advocates in Coordination with Chandigarh Judicial Academy during the year 2022-2023 whereby 37,191 participants have attended the training. Furthermore, 07 ECT Training programmes are being organized for the stakeholders mentioned above from January to March, 2024. Training about various subject matters such as Readers Module, LibreOffice, Neutral Citation, e-Filing, Video

Use of Artificial Intelligence Tools for Translation of Judgements: Under the directives of the Supreme Court, 4,073 Supreme Court judgments have been translated into Punjabi using the AI tool SUVAS and other online Additionally, tools. approximately 9,356 Puniab Haryana High Court judgments have been translated into Punjabi and Hindi and uploaded on the Court's website for wider legal literacy.
