ORDER

SUB: DETENTION OF STAFF FROM 31.08.2021 to 30.09.2021

In pursuance of the directions contained in order bearing no. 569/RG/DHC/2021, dated 19.08.2021, received from the Hon'ble High Court of Delhi and in continuation of earlier order no. 6639-50/Admn./PD&SJ/SHD/2021 dated 13.08.2021, all the Judicial Officers of Shahdara District, Karkardooma Courts, Delhi may call the staff physically as per requirement for facilitating the judicial work.
