- 2. Endeavour shall be made to take up stay applications, bail applications and other miscellaneous urgent matters on physical days, wherever request to such effect is made.
- 3. On physical hearing day of the Additional Sessions Judges of Shahdara District dealing with bail matters as per the Bail Roster issued by this Office, in addition to his regular board, such roster judge, shall also deal with fresh bail applications in those cases, where investigation is pending and the counsel has made a specific request for hearing the matter in physical court. Such bail applications shall, as far as possible, be disposed of by the same roster Judge.
- 4. It is to inform that the earlier direction issued by the Hon ble High Court of Delhi vide Office Order no. 256/RG/DHC/2021 dated 08.04.2021 that no adverse orders shall be passed by the District Courts in Delhi in case of non appearance of parties and/or their counsel stands withdrawn w.e.f. 24.08.2021.
- 5. On physical hearing days, the Courts of Shahdara District shall, wherever possible, permit hybrid/video conferencing hearing where a request to such effect is made by any of the parties and /or their counsel.
- 6. The Judicial Officers shall hold physical hearing in their respective court rooms on the date mentioned in the Roster and while the others continue to hold courts through video-conferencing mode/virtual mode, as per the existing arrangments, on non physical days. However, the Duty Magistrates shall continue as it is.
- 7. All the stake holders of Shahdara District Courts, Karkardooma Courts, Delhi are requested to strictly adhere to the norms of social distancing and other Covid-19 related guidelines/protocols issued by the Hon'ble High Court of Delhi, Central/State Government. Deep cleaning of all court rooms of Shahdara District shall be carried out by the Care Taking Branch, Shahdara District, Karkardooma Courts, Delhi on daily basis.
- 8. The duties of Metropolitan Magistrate (Reliever) shall be assigned by the CMM, Shahdara District, Karkardooma Courts, Delhi.
