Considering the threat of Delta Plus a variant of concern (VoC) and pursuant to the directions contained in order bearing no. 372/RG/DHC, dated 28.06.2021, received from the Hon'ble High Court of Delhi and in continuation of earlier orders of this office bearing no. 3115-3125/Admn./D&SJ/SHD/2021, dated 12.04.2021 & 4021-4029/Admn./D&SJ/SHD/2021, dated 23.04.2021, & 5162-5171/Admn./PD&SJ/SHD/2021, Dated 03.06.2021, all the Judicial Officers of Shahdara District, Karkardooma Courts, Delhi, may call minimum number of staff as deemed necessary for facilitating the judicial work for smooth functioning of the Courts of Shahdara District.

It is hereby directed to all the A.O.(Judl.)/Branch In-charges posted in Shahdara District to prepare a roster to ensure that officials posted in their respective Branches, are reporting for duty on proportionate/rotational basis w.e.f. 01.07.2021 to 23.07.2021 and to ensure that their footfall is reduced to **one third**. The roster of staff so prepared be submitted before the A.O. (Judl.)/ Incharge, Administration, Shahdara District positively by 30.06.2021.

Further, it is hereby directed that all those staff officials, who are not required to report for duties (physically), shall not leave the station under any circumstances (without getting prior sanction) and shall always be available on call and would be deemed to be on duty. In case of any urgency, concerned Judicial Officer/Officer In-charge or Administrative Officer (Judicial) may call upon them to report back for duty immediately.

Furthermore, it is directed to adhere to the norms of social distancing and all other Covid-19 protocol, guidelines, directions etc. issued by the Government of India, Government of NCT of Delhi and Hon'ble High Court of Delhi, New Delhi from time to time. All the Judicial Officers as well as the staff members posted in Shahdara District, who have not got themselves vaccinated till date, are advised to get themselves vaccinated at the earliest.
