It is hereby directed that all the A.O.(Judl.)/Branch In-charges posted in Shahdara District are directed to prepare a roster to ensure that officials posted in their respective Branches, are reporting for duty on proportionate/rotational basis to ensure that their footfall are enhanced from one third to 50% w.e.f. 24.07.2021 to 13.08.2021. Further, the A.O.(Judl.)/ Incharge, Administration, Shahdara District may call more than 50% percent staff for physical duty in official exigency, if required.
