The system analyst at Tis Hazari Courts, Delhi, can then digitally enroll such Lawyers in E-filing.

The greater the zeal to get registered, the greater will be the convenience to the Advocates, who can then file cases from the comfort of their homes or offices without moving out and inviting any danger to contact COVID-19.
