OFFICE ORDER

SUBJECT: SYSTEM OF HEARING OF CASES IN SHAHDARA DISTRICT, KARKARDOOMA COURTS, DELHI WITH EFFECT FROM 01.11.2021.

Pursuant to the directions received vide Order no.798/RG/DHC/2021 dated 29.10.2021 of Hon'ble High Court of Delhi. New Delhi, it is to inform that in continuation to the Orders no. 504/RG/DHC/2021 dated 12.08.2021, No. 569/RG/DHC/2021 dated 19.08.2021 and No. 700/RG/DHC/2021 dated 30.09.2021, the Hon'ble Full Court of Hon'ble High Court of Delhi, New Delhi has been pleased to order that the existing mechanism of hearing of matters in the District Courts in Delhi shall continue till 20.11.2021 and that there shall be complete resumption of physical Courts w.e.f. 22.11.2021. The Courts shall, however, permit hybrid/video conferencing hearing where a request to such effect is made by any of the parties and/or their counsel.

In view of the above directions of Hon'ble High Court of Delhi, New Delhi, the Judicial Officers of Shahdara District shall continue with the existing mechanism of hearing of matters in Shahdara District Courts till 20.11.2021 and that there shall be complete resumption of physical Courts w.e.f. 22.11.2021 in Shahdara District, Karkardooma Courts, Delhi. The Courts of Shahdara District shall, however, permit hybrid/video conferencing hearing where a request to such effect is made by any of the parties and/or their counsel.

The Judicial Officers of the Shahdara District shall hold the physical courts as per schedule/roster given below and while the others hold courts through virtual mode, w.e.f 01.11.2021 to 20.11.2021.

- 6. The duties of Metropolitan Magistrates (Reliever) shall be assigned by the CMM, Shahdara District, Karkardooma Courts, Delhi.
