The Metropolitan Magistrates (Reliever), shall look after the work of 'extending the J/C remand of the UTPs to be produced from the prison, assigned to Shahdara District, through VC; Conducting the TIP/s of the case properties; TIP/s of the CCL/s link duty, TIP, inquest proceedings, recording statement under Section 164 Cr. P.C. besides administrative duties as per order NO. 71/DHC/Gaz/G-7 N.E.2(a)/2020 dated 18.11.2020 of the Hon'ble High Court of Delhi, which might be assigned to them by order of the Ld. Principal District & Sessions Judge (Shahdara), and by the Chief Metropolitan Magistrate, Shahdara.

Remarks:

- The work of TIP shall continue to be done by the jail duty magistrates (as per jail duty roster) till next order.
- The Metropolitan Magistrates (Reliever), are advised not to take leave on the day he/she is assigned the duty as per the roster prepared hereinabove. However, he/she may change his/her day of duty/ies on mutual exchange basis with his/her Link MM(Reliever) well in advance. If the Metropolitan Magistrates (Reliever), is not available on any day of his/her duty, due to some unavoidable reasons, then his/her link MM(Reliever) shall perform the duty in his/her place. If both of them are on leave on a particular day or not available for some unavoidable reasons, the third MM(Reliever) shall perform the duty on that day.
