Remarks:

- The work of TIP shall continue to be done by the jail duty magistrates (as per jail duty roster) till next đ order
- The Metropolitan Magistrates (Reliever), are advised not to take leave on the day he/she is assigned the duty as per the roster prepared hereinabove. However, he/she may change his/her day of duty/ies on mutual exchange basis with his/her Link MM(Reliever) well in advance. If the Metropolitan Magistrates (Reliever), is not available on any day of his/her duty, due to some unavoidable reasons, then his/her link MM(Reliever) shall perform the duty in his/her place.
