## OFFICE ORDER

As per the directions of Hon'ble High Court of Delhi contained in Office Order no. 35/RG/DHC/2021 dated 14.01.2021, the Judicial Officers of the Shahdara District shall hold the physical courts on alternate basis as per schedule/roster given below and continue to take up the matters through 'video conferencing' on non-physical days, w.e.f 01.02.2021 to 28.02.2021.

In pursuance to the directions of Hon'ble High Court of Delhi in the above Order, all the Judicial Officers of Shahdara District, Karkardooma Courts, Delhi shall record evidence (except in those cases where the accused is in custody) while scrupulously adhering to the norms of social distancing when holding Courts physically. The Under Trial Prisoners shall be produced before the physical courts w.e.f 01.02.2021 and thereafter their cases shall be taken up on priority basis and evidence be also recorded in such matters.

The Advocates, litigants and other visitors to the Shahdara District Courts, Karkardooma Courts Complex, Delhi are requested to strictly adhere to the norms of social distancing and other Covid-19 related guidelines issued by Central/State Government.

- The Judicial Officers shall hold physical hearing in their respective court rooms on the date mentioned in the Roster and continue to take up the matters through 'video conferencing' on non-physical days from their chamber/homes. However, the Duty Magistrates and Bail ASJ Courts shall continue as it is.
- 2. Physical hearing shall take place in two sessions 10.30 am to 12.30 pm and 2.00 pm to 3.30 pm and the sessions in which the hearing is to take place shall reflect in the cause list. The Judicial Officers shall ensure that on the day when they hold physical court in the said two sessions, it shall specify which cases shall be taken up in first session (from 10.30 a.m. to 12.30 p.m.) and which cases shall be taken up in second session (from 2.00 p.m. to 3.30 p.m.).
- 3. The Judicial Officers dealing with the criminal jurisdiction are directed to ensure that in order to prevent over-crowding in the court rooms, services of Naib Court be utilized for delivering/collecting daily dak only. The Naib shall be allowed to remain present in the court rooms during the proceedings as per the directions of the concerned court.
- 4. Daily deep cleaning of all court rooms shall be carried out before opening of courts, between 12.30 pm to 1.30 pm and at 04.00 pm.
- 5. The Judicial Officers are requested not to proceed on leave on the dates of physical hearing unless and until there is extreme urgency. The entire staff shall report for duty on day when the Presiding Officers would be holding Court physically.
- 6. The duties of Metropolitan Magistrate (Reliever) shall be assigned by the CMM, Shahdara District, Karkardooma Courts, Delhi.
