**ORDER**

In view of the earlier orders of the Hon'ble High Court of Delhi, the Judicial Officers of Shahdara District shall be permitted to come to court for holding video conference hearings from their respective chambers only when they do not have requisite technical infrastructure at their residences or where there is a breakdown of such infrastructure **till 14.03.2021**. Physical hearings shall be permitted in those matters only where a grave urgency is involved and hearing through videoconferencing is not feasible. In all such instances of physical hearings, the norm of social distancing be scrupulously adhered to.

Further, in pursuance to the Office Order no. 123/RG/DHC/2021 dated 20.02.2021 of Hon'ble High Court of Delhi, all the Judicial Officers of the Shahdara District, Karkardooma Courts, shall hold regular physical courts, on a daily basis, as per regular court timings **with effect from 15.03.2021** and shall take up all cases fixed before them.

Rest of the conditions mentioned in the previous orders of this office shall remain the same.
