It has been brought to the notice that some of the courts are still not following the directions issued in the above said circular, therefore, you are again requested to direct the concerned staff officials of the respective court to follow the instructions regarding mentioning of the CNR number (CNR Number is available in CIS 3.2 software) in Order Sheets, Judgments' and also in all correspondence made with Jail authorities mandatorily.

Non-compliance of the directions would invite strict disciplinary action.
