**ORDER**

**SUB: DETENTION OF STAFF FROM 16.08.2021 to 28.08.2021**

In pursuance of the directions contained in order bearing no. 504/RG/DHC/2021, dated 12.08.2021, received from the Hon'ble High Court of Delhi, wherein it has been ordered that the existing system of hearing in the District Courts in Delhi shall continue upto 28.08.2021 and physical hearings in the District Courts in Delhi be resumed in a restricted manner w.e.f. 31.08.2021, provided the scale and magnitude of the Covid-19 pandemic in the NCT of Delhi remains well under control and in continuation of earlier orders of this office bearing no. 3115-3125/Admn./PD&SJ/SHD/2021, dated 12.04.2021 4021-4029/Admn./PD&SJ/SHD/2021, dated 22.04.2021, 5162-171/Admn./PD&SJ/SHD/2021, dated 03.06.2021, 5450-59/Admn./PD&SJ/SHD/2021, dated 29.06.2021 and 6268-79/Admn./PD&SJ/SHD/2021, dated 23.07.2021, all the Judicial Officers of Shahdara District, Karkardooma Courts, Delhi are advised not to call more than 50% of staff physically for facilitating the judicial work unless it is absolutely necessary, till 28.08.2021.

It is hereby directed that all the A.O.(Judl.)/Branch In-charges posted in Shahdara District are directed to prepare a roster to ensure that officials posted in their respective Branches, are reporting for duty on proportionate/rotational basis to ensure that their footfall would be restricted upto **50% w.e.f. 16.08.2021 to 28.08.2021**. However, the A.O. (Judl.)/Incharge, Administration, Shahdara District may call more than 50% staff for physical duty in official exigency, if required.

All the Officials are also advised to get themselves vaccinated at the earliest.

Rest of the instructions/ directions as mentioned in the previous orders shall remain same.
