CIRCULAR

All Judicial Officers posted in Delhi District Courts are requested to download, install and use SANDES App developed by National Informatics Centre (NIC) for sharing official communication quickly (earlier known as GIMS- Government Instant Messaging System).

The SANDES App is available for Android and Apple iOS version and is equivalent to other instant messaging applications such as WhatsApp, Telegram and is a **Made in India** App. The servers of SANDES App are situated in India and maintained by NIC. SANDES App facilitate the users to not only send text messages, audio messages, make voice and video calls, share images, documents peer to peer but also communicate in a Group with end-to-end encryption.

The Apple iOS users can download the latest version of SANDES App (Ver. 2.0.12) from the Apple App Store. The Android users can download the latest version of SANDESAPP (Ver. 2.0.5 from <https://www.gims.gov.in>) by signing-in through either of the two modes provided on the website. A user can log-in/sign-in by using their email addresses for e.g. xxx@AIJ.GOV.IN or xxx@NIC.IN or mobile phone number and password/OTP by visiting the webpage <https://www.gims.gov.in>
