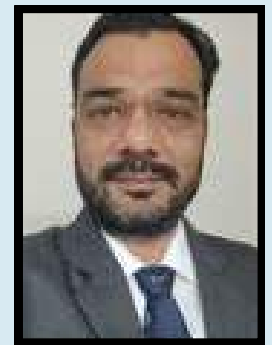

## Academy At a Glance

The foundation stone for the new building of the Rajasthan State Judicial Academy (RSJA) was laid on March 12, 2011, by esteemed dignitaries including Hon'ble Mr. Justice R.V. Raveendran and Hon'ble Mr. Justice G.S. Singhvi, Judges of the Hon'ble Supreme Court of India, along with the Hon'ble Chief Minister of Rajasthan, Mr. Ashok Gehlot. This significant event was graced by the august presence of Hon'ble Mr. Justice Arun Mishra, then Chief Justice of the Rajasthan High Court, and other Hon'ble Judges of the Rajasthan High Court. The construction of the building was entrusted to the Rajasthan State Road Development and Construction Corporation Limited.

The inauguration of the new RSJA building took place on September 26, 2015, in the auspicious presence of Hon'ble Mr. Justice Amitava Roy, Judge of the Supreme Court of India. The event was further honored by the presence of Hon'ble Mr. Justice Ajit Singh, then Acting Chief Justice of the Rajasthan High Court, Hon'ble Mr. Justice Govind Mathur, then Chairman of RSJA, and other distinguished Judges of the Rajasthan High Court, along with various esteemed dignitaries.



**Administrative Block**

This is the Administrative Block of the Rajasthan State Judicial Academy. It comprises the offices of the Hon'ble Chairman of RSJA, the Director, the Additional Director (Administration & Academics), and the Deputy Directors (Academics & Administration). Additionally, it houses a conference room and staff offices for both academic and administrative functions.

## **Academic Block**

Academic Block, is equipped with modern facilities designed to enhance the learning experience. The block features a spacious Auditorium with a seating capacity of 234, boasting a 219-inch Full HD Video Wall for immersive presentations. Additionally, it includes a Conference Hall that can accommodate 134 participants, alongside two classrooms: Classroom I with a capacity of 90 and Classroom II, a round table conference room with a capacity of 25, equipped with video conferencing facilities. The Academic Block also houses a well-stocked Library Hall and a dedicated Computer Room, providing a comprehensive environment for judicial education and training.

## **Officer's Hostel**

The Hostel Block of the Rajasthan State Judicial Academy (RSJA) includes 90 air-conditioned rooms, with 7 Super Deluxe Rooms offering additional space. The block is designed for comfort and convenience, with a Mess providing easy access to meals, ensuring a restful stay for officers after training sessions.

## Guest House



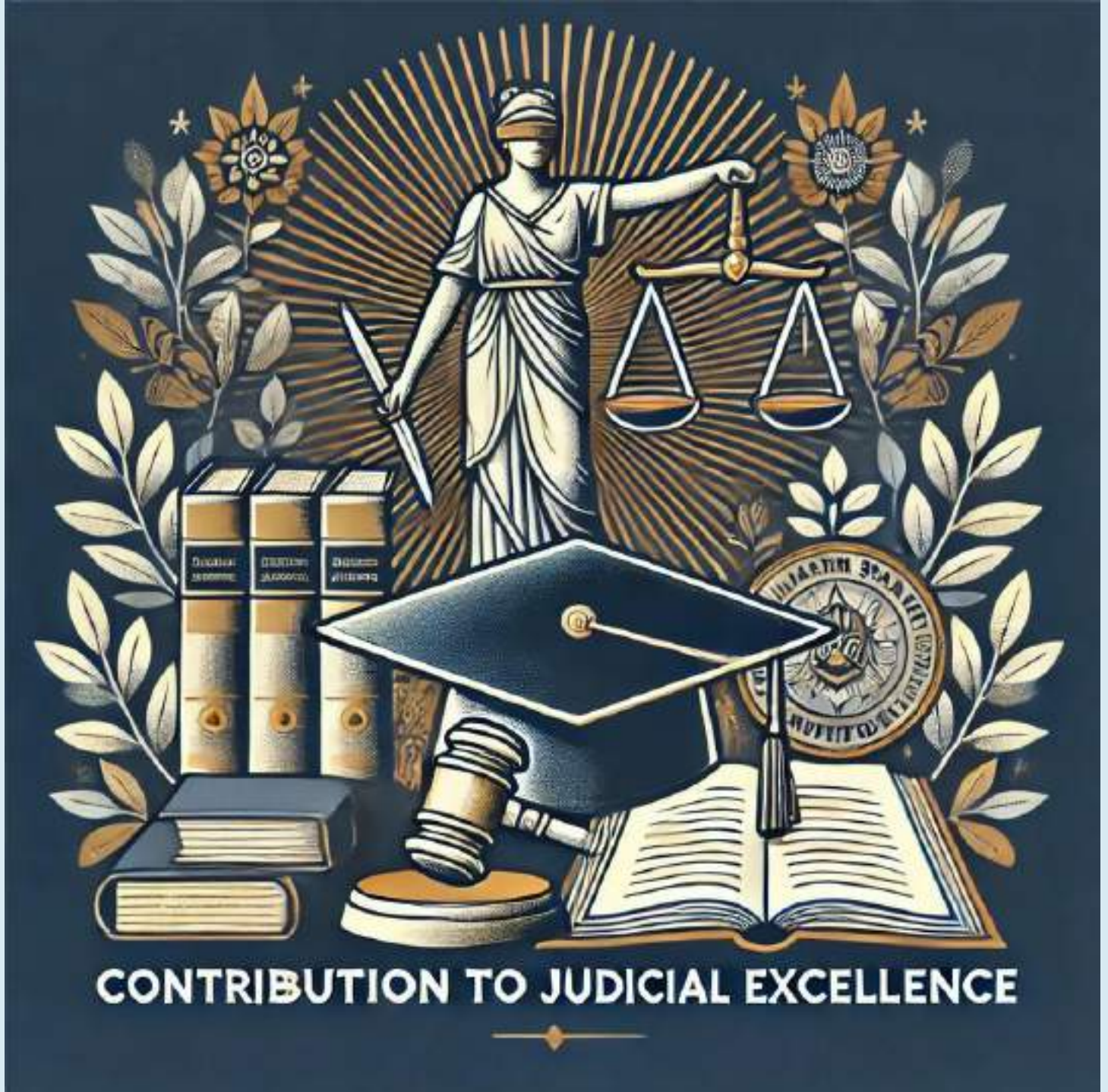

The Rajasthan State Judicial Academy hosted a Judicial Colloquium on 21st January 2024, focusing on the Sensitization of Stakeholders on Prevention of Human Trafficking. The event was inaugurated by Hon'ble Ms. Justice Rekha Borana, Judge, Rajasthan High Court, who underscored the critical roles of various stakeholders, including judicial officers, law enforcement, and NGOs, in combating human trafficking. The colloquium featured sessions led by distinguished experts, including Mr. Mahendra Kumar Dave, Dr. Amrita Duhan (IPS), and Mr. Ravi Kant, who provided insights into the legal frameworks, investigative challenges, and the importance of a victim-centered approach in addressing this grave issue.

The discussions highlighted the complexities of human trafficking as an organized crime and emphasized the need for procedural safeguards, collaboration between police and prosecutors, and the crucial role of NGOs in supporting and rehabilitating victims. The colloquium reinforced the importance of coordinated efforts across all sectors to effectively prevent and address human trafficking in India.

The Rajasthan State Judicial Academy, Jodhpur, recently hosted a one-day training programme on 5th May 2024, centered on the "Expeditious Trial and Qualitative Disposal of NI Act Matters." The programme, inaugurated by Hon'ble Dr. Justice Pushendra Singh Bhati, Judge of Rajasthan High Court and Chairman of RSJA, brought together 88 Judicial Magistrates from across the state.

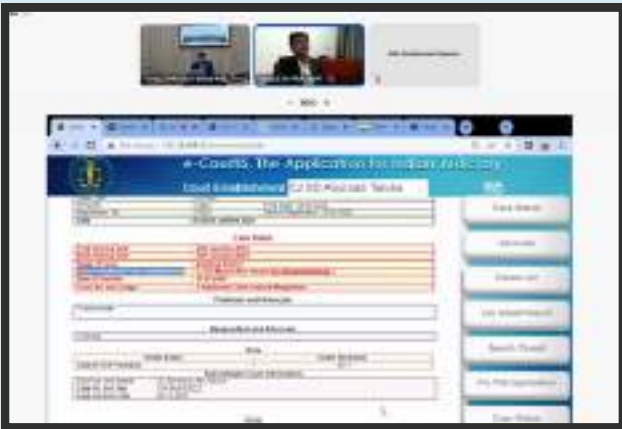
The training began with a session on the general principles governing NI Act trials, covering critical aspects such as service of notice, the limitation for cognizance, and handling the second or successive dishonor of cheques. The session emphasized the importance of overcoming common delays and adhering to best practices to ensure expeditious trials.

Another session focused on the practical procedures under the NI Act, discussing the significance of interim compensation, managing non-appearance and the death of complainants or accused, and the process of compounding offenses under the Act. The session aimed to equip participants with the necessary tools to handle such cases efficiently.

The final session addressed sentencing guidelines, the imposition of fines, and the application of the Probation of Offenders Act in NI Act cases. The discussion highlighted the importance of ensuring fairness and justice while navigating these legal matters.

The programme concluded with a vote of thanks to all contributors for their invaluable insights, which will greatly assist Judicial Magistrates in effectively managing NI Act cases and reducing case pendency.

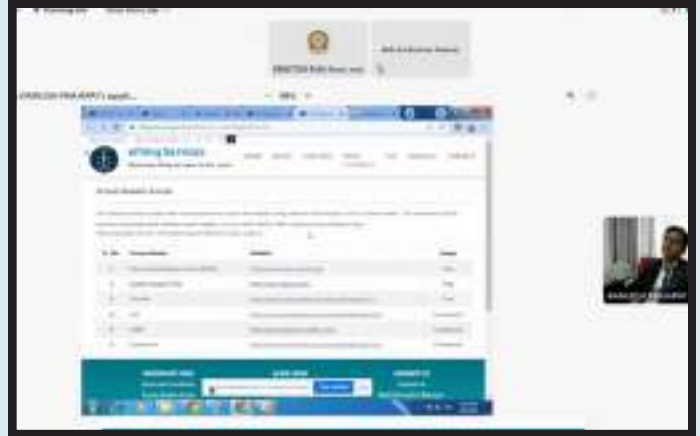

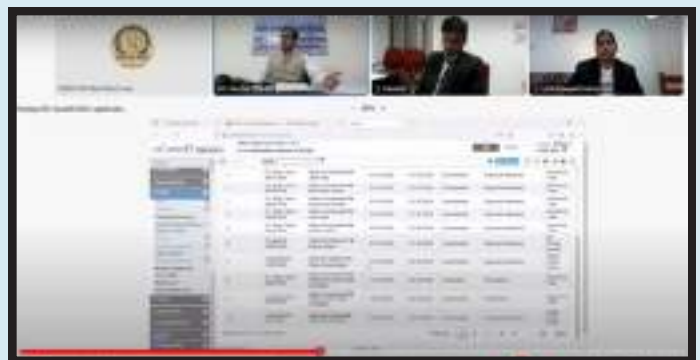

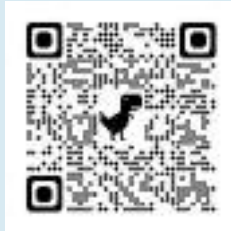
