Sir,

I am directed to refer you on the subject cited above and to inform you that Hon'ble the Chief Justice and Judges have been pleased to pass following decision on 20.05.2022

"..... This Court has its own outsourcing policies dated 24.12.2009 and 26.10.2021 regarding engagement of Sweepers and Malls in the States of Punjab, Haryana and U.T Chandigarh, who are being paid the wages as prescribed by the respective Deputy Commissioner. In view of the fact that the Government of Haryana, vide letter dated 19.01.2022 has decided to withdraw the DC rates, so prescribed by the Deputy Commissioners under various instructions and the Deputy Commissioner have been asked not to prescribe any such rates, the Committee recommends that henceforth the contractual/outsourced employees engaged by the District Judges in the State of Haryana Under policies dated 24.12.2009 and 26.10.2021 and other orders issued by this Court shall be paid

the wage rates , as prescribed by the Government of Haryana vide its letter dated 19.01.2022 or the ones as may be revised by the State Government from time to time.

You are, therefore, requested to take necessary action in the matter.


