III	Pay Band :	Pay Matrix of Level-4 (Rs. 25,500 - Rs. 81,000) of the 7 th Pay Commission & other allowances as admissible under the rules plus one increment as per the recommendation of Justice Shetty Commission.
IV	Age :	The candidate must not be less than 18 years and more than 45 years of age on the date of publication of this advertisement. The maximum age limit shall not be applicable to the Government Employees. Further, the age limit shall be relaxed by five years [i.e. upto 50 years of age] in case of candidate belonging to Scheduled Castes/Scheduled Tribes and CFF, by 3 years [i.e. upto 48 years of age] for Other Backward Classes, PwD by 10 years and Ex-Serviceman upto the extent of service rendered by the candidate.
V	Qualification :	
		1 The candidate must possess Higher Secondary School Certificate from a recognized Board/ Institution.
		2 The candidate must possess speed of 100 w.p.m. in Shorthand in English (Certificate issued by/obtained from online websites will not be accepted)
		3 The candidate must possess speed of 35 w.p.m. in English Typing (Certificate issued by/obtained from online websites will not be accepted).
		4 The candidate must possess sufficient knowledge of Computers.
		5 Knowledge of Konkani is essential.

		(c)	Typing test : 40 marks (minimum passing marks 20). Duration : 10 minutes Typing passage containing simple language of 350 words. The typing test will be taken on Computer only. No grievance about condition of computer provided by the Office will be entertained after commencement of the Test.
		(d)	Qualification : 20 marks
		(e)	Verification of Documents
		i)	If the candidate fails in typing test/shorthand test the candidate will not be considered for the post of Stenographer Grade-III.

		3	Verification of documents & testimonials with the Originals shall be done at the time of Shorthand or Typing test. Only eligible candidates will be allowed to appear for the Shorthand and Typing test.
		4	The Schedule of recruitment process is subject to change on account of any unforeseen events beyond the control of the Court of the Principal District and Sessions Judge, North Goa, Mercas, Tiswadi-Goa. Such change would be published on the Official website of the District and Sessions Court, North Goa, Mercas, Tiswadi-Goa from time to time.

		2	The eligibility of the candidates shall be finally decided after scrutiny of the applications.
		3	The list of eligible candidates shall be notified on the website of the District and Sessions Court, North Goa, Mercas, Tiswadi-Goa.
IX Select/Wait List :			
		(a)	On the basis of performance of the candidates in the tests, a Select List and Wait List of candidates shall be prepared, for the above said posts, in the order of merit and the same will be notified on the Official website of the Court of the Principal District and Sessions Judge, North Goa, Mercas, Tiswadi-Goa, after the selection process is over in every respect.
		(b)	The Select List and Wait List so prepared and approved shall ordinarily be valid for a period of two years from the date of its notification.
		(c)	The appointment to the above said post shall initially be on the probation for a period of two years. During the period of probation and until certificate about satisfactory completion of probation period is issued, the service of the appointee shall be liable to be terminated at any time without any notice and without assigning any reason.

Applications received thereafter or sent by any other mode such as Ordinary Post or by Hand Delivery will not be accepted

		k)	Candidate registered with the Employment Exchange must enclose a copy of the Employment Exchange Registration Certificate.
		l)	Three additional latest coloured passport size photographs. (As mentioned above at Sr. No. X (one) to be affixed on the application form).
		m)	In case of change in name, document regarding change of name, such as copy of divergence/marriage certificate issued by the Competent Authority.
