

NOTICE

It is notified for all concerned that in pursuance of Employment Notice published by this Registry on 19th July, 2023 for recruitment to the post of Stenographer/P.A. (Reserved for Scheduled Caste category) in the establishment of the Circuit Bench of Calcutta High Court at Port Blair, in total 43 (forty-three) online applications were received from candidates, out of which 25 (twenty-five) candidates have been found eligible, 04 (four) candidates have been found provisionally eligible and the remaining 14 (fourteen) candidates have been found ineligible to apply for the post advertised.

Ambedkar Institute of Technology, Pahar Gaon, Port Blair, Andaman & Nicobar Islands.

The eligible/provisionally eligible candidates shall have to download their Admit Cards online through the website '<https://erecruitment.andaman.gov.in/crap>' OR by following the e-Recruitment link in the website 'www.andaman.gov.in' during the period from 01.09.2023 till 02.10.2023.

Candidates called for the examination (dictation and typewriting on computer) shall be required to appear at the examination venue on the date mentioned above at least one (01) hour prior to the scheduled start of the examination at their own expenses and no T.A./D.A. shall be admissible to any of the candidates.

Candidates must bring A-4 size colour printout of Admit Card (both sides) and at least one original valid Photo Identity Proof documents, viz., Passport, PAN Card, Voter Identity Card, Aadhaar Card, Driving License (along with a photocopy thereof) to the examination venue for verification and in case of failure, candidate will not be allowed to appear at the examination.


