The Presiding Officers shall also ensure that taking of the photocopies and their issuance are streamlined and smoothened out so that there is no delay in the issuance of the Certified Copies.

It is impressed upon the Ahlmad(s) and the Examiner(s) that delay in issuance of Certified Copies will be viewed seriously.
