

MINUTES OF THE MEETING OF THE LAWYERS CHAMBER ALLOTMENT COMMITTEE AT DISTRICT COURT COMPLEX, SAKET NEW DELHI HELD ON 02.05.2017 AT 04.30 PM IN THE CONFERENCE HALL ADJACENT TO COURT NO.300, 3rd FLOOR, DISTRICT COURT COMPLEX, SAKET, NEW DELHI.

Mr. Girish Kathpalia, Ld. District & Sessions Judge (South-East) was welcomed by the Chairperson and other members of the Committee, after having recently taken charge as District & Sessions Judge, South-East District, Saket Courts, Saket.

1. Report of Sub-Committee of LCAC regarding Seniority List.

The Office has reported that as per directions in the last meeting held on 04.03.2017, list of 855 applicants who had applied for allotment of chambers was sent to the Saket Bar Association and in response, they have submitted the membership number of the Saket Bar Association of these 855 applicants. The Office had been asked to draw up a list based on the date of Bar Council of Delhi enrolment and membership of Saket Bar Association. The Office reports that the work has commenced but will take some more time. They are directed to expedite the matter.

This issue is deferred for consideration in the next meeting.

This issue is deferred and will be considered in the next meeting at the time of considering Issue No.1.

- 6. Representation dated 03.03.2016 of Sh. Rajinder Kumar, Advocate for withdrawal of application no. 373 on the ground that inadvertently he had submitted**

two applications for allotment of chamber. The second application no. is 844.

This issue is deferred and will be considered in the next meeting.

7. Copy of Report of ACJ's received on 02.07.2016 regarding inspection of Lawyers Chamber Block.

This issue is deferred and will be considered in the next meeting.

8 (i) Regarding hand over the possession and payment of outstanding dues of chamber no. 449 by the spouse of the allottee namely Mr. Sanjay Chaudhary as he had expired and chamber had already been cancelled on 09.09.2015.

ii) Representation dated 19.10.2015 of Sh. Yogesh Baisoya intimating that allottee of Chamber no. 449, Sh. Sanjay Chaudhary has been expired and to take further action in the matter.

In respect of Chamber No. 449, it is informed that Sh. Sanjay Chaudhary expired and his allotment of chamber in his favour had already been cancelled on 09.09.2015. Though the possession of the same, has not been handed over to the PWD by the spouse / kin of the allottee.

Discussed.

The committee unanimously resolved that notice for vacation of the Chamber No. 449 (Slot on Double Occupancy Basis) be issued to the spouse / kin of late Sh. Sanjay Chaudhary to hand over the possession of Chamber No.449 to the Astt. Engineer (Civil), PWD within 10 days from the date of receipt of the notice and also deposit the outstanding license fee and maintenance charges in this office. Notice be also served by way of affixation at the available addresses and the chamber. It is further resolved in the event of failure of the spouse/kin to hand over the vacant possession after the lapse of 15 days from the date of receipt of the notice for vacation, the PWD (Civil) is directed to take immediate possession of Chamber No.449 (Slot on Double Occupancy Basis) and submit the necessary report.

9. Application dated 29.02.2016 of Sh. Brajesh Kumar, Advocate for surrender of Ch. No. 882 (Double Occupancy Basis), 1st Allottee. In the application he has submitted that he was allotted ch. no. 882 subject to rules. He has further submitted that the O/o AE, PWD got the papers signed from him i.e. occupancy report but the keys of the said chamber was not handed over to him and the physical possession of the chamber still with the PWD. He has also submitted that due to unavoidable reasons he did not ask for the physical possession.

On the application, report was called from the AE, PWD. Vide letter dated 21.03.2016, he has informed that key of the chamber no. 882 was not taken over by Sh. Brajesh Kumar since 03.02.2014 i.e. the date when occupation report was signed by him, as the allottee did not ask for physical possession.

Discussed.

It is unanimously resolved that reminder notice be sent to the allottee for making the payment of the dues as the occupancy report was signed by the allottee.

10. **Representation received on 27.05.2015 from Sh. Naresh Kumar, Advocate, allottee of Chamber No.216 (Double Occupancy Basis) for Allotment of Single Chamber against cancellation.**

This issue is deferred and will be considered in the next meeting.

11. **Application dated 11.03.2016 of Sh. Subhash Chander Suri, Advocate, Allottee No. 2 of Ch. No. 276 (Double Occupancy Basis) for allotment of Ch. No. 276 on Single Occupancy Basis.**

This issue is deferred and will be considered in the next meeting.

12. **Representation dated 23.07.2016 of Sh. Nirnajan Saha, Advocate allottee of chamber no. 216(double occupancy basis) for upgradation of allotment of chamber from double occupancy to single occupancy.**

This issue is deferred and will be considered in the next meeting.

13. **Fresh application for allotment of Chamber of Sh. Harnam Singh Sharma under rule 8 (ii) (Category Reserved for Retired Judicial Officer);**

14. **Fresh application for allotment of Chamber of Sh. Dal Chand Anand under 8 (ii) (Category Reserved for Retired Judicial Officer);**

Issue No.13 & 14 are taken up together.

The Office has reported the receipt of two applications of Sh. Harnam Singh Sharma and Sh. Dal Chand Anand against the reserved category of Retired Judicial Officers with reference to notice published on 21.08.2013.

The Office has prepared and submitted a Master List CC3/G of the above applicants.

The applications were subjected to scrutiny and considered. It is unanimously resolved that the application of Sh. Harnam Singh Sharma be deferred for consideration and request of Sh. Dal Chand Anand be approved. The Committee recommends for allotment of chamber to Sh. Dal Chand Anand under reserved category of Retired Judicial Officers, Under Rule 8 (ii) of the Saket District Court Lawyers Chambers (Allotment & Occupancy) Rules, 2010. The decision is shown in the list FF2/G. The Branch In-Charge LCAC was asked to take follow up action.

15. **Surrender of four slots.**

The Office has submitted report (**Annexure A**) to these Minutes regarding the acceptance letter submitted by Mr. Rohitash, Mr. Yogesh Basioya and Mr. Ankur Aggarwal in response to the offer letters issued to them as per decision taken in the meeting of LCAC held on 22.02.2017.

Mr. Rohitash, NDBA Seniority No. 3779 has submitted his preference for allotment of slot in chamber number 506.

Mr. Yogesh Basioya, NDBA Seniority No. 3787 has submitted his preference for allotment of slot in chamber number 763.

Mr. Ankur Aggarwal, NDBA Seniority No. 3797 has submitted his preference for

allotment of slot in chamber number 347 or 425 or 506.

The Office has reported that one slot each in Chamber No.506 and 347 are available for allotment and both the slots in Chamber No.763 are available for allotment.

After deliberation, it is unanimously resolved that one slot available in Chamber No.506 be allotted to Mr. Rohitash and one slot available for allotment in Chamber No.347 be allotted to Mr. Ankur Aggarwal. Since, Mr. Yogesh Basioya had given preference for allotment of slot in Chamber No.763 and as per report of the office that both the slots are available for allotment, the Committee is of the view that Mr. Yogesh Basioya be asked to give preference for allotment of slot in a chamber where one slot has already been allotted.

List E-23 be issued as per previous practice.

Against one slot left for allotment out of four slots:-

The office has reported that as per decision taken in the meeting of LCAC held on 22.02.2017, letters were sent to Ms. Budhimati Jha, NDBA no. 3806, Mr. Chander Parkash, NDBA no. 3809 and Mr. Vijay Pal, NDBA no. 3811 for submitting all requisite documents as per S. No. 19 of the approved application form within 10 days from the date of receipt of letter issued by the office.

The office has further reported that in response, Ms. Budhimati Jha has submitted certified copies vide letter dated 20.03.2017, Mr. Chander Parkash was served by Process Server through his brother on 16.03.2017 and by speed post on 07.03.2017, however no response was received from Mr. Chander Parkash and Mr. Vijay Pal was served through Process Server through his Bua Mrs. Meenakshi on 07.03.2017 and the letter sent through speed post at the address of Begumpur was served on 07.03.2017 and letter sent through speed post at his village address received back unserved as incomplete address, however no response was received from Mr. Vijay Pal.

The office has further reported that a copy of order dated 10.03.2017 passed by the Hon'ble High Court of Delhi in Writ Petition (C) No. 2296/2017 titled "Siddhartha Mohan Vs Saket Bar Association & Anr" has been received vide representation dated 16.03.2017 of Mr. Siddhartha Mohan, Advocate. By way of this order, the Hon'ble High Court of Delhi has directed that till the next date of hearing, if there is a slot/chamber vacant, the same shall be kept reserved and not allotted.

Discussed.

In view of the stay order of the Hon'ble High Court of Delhi, the available slot will not be allotted till the receipt of the decision of the Hon'ble High Court of Delhi in the aforesaid Writ Petition.

16. Non payment of dues by allottee of chambers

i) 19 Chambers were cancelled.

11 Chambers have been restored. Report of remaining 8 allottees is ready for consideration.

Status Report prepared as per decision taken in the meeting of Hon'ble BMCC (SCC), Hon'ble High Court of Delhi, New Delhi regarding 08 cancelled chambers is in the file.

ii) Fresh List of defaulters is placed for consideration.

17. Notice under Rule 23, sent to

i) Sh. Yogendra Kumar, Allottee No. 1 of Chamber no. 314.

Payment made till Nov. 2014. The matter was considered in the meeting held on 05.08.2015 representation of Mr. Yogendra Kumar was allowed and he was granted time to deposit the dues upto sept. till 30.08.2015.

Notice was sent on 20.08.2015 and the same was served by way of Regd. AD post at chamber address. Notice sent at their residential addresses were received back unserved as Left the Address.

He has not deposited the dues from Aug. 2015 till date.

ii) Sh. Om Kumar Sharma, Allottee no. 2 of Chamber no. 555.

Payment made till March, 2015.

In the meeting held on 05.08.2015, on the request of Hony. Secretary he was granted time to deposit dues upto Sept. 2015 till 30.08.2015.

A letter dated 20.08.2015 was sent vide Regd. AD and Process Server. Notice sent by Process Server at his Chamber Address received back with the report that "premises was locked". Notice sent by Regd. AD Post at his Chamber Address, the same was served. AD Card received.

Issue No.s 16 & 17 are taken up together.

Discussed.

It is observed by the members of the Committee that since despite repeated notices sent from the Office of District & Sessions Judge (South) as well as by the Saket Bar Association, several allottees as per list submitted by the Office placed as **Annexure 'B'** to these Minutes, have not paid their respective license fees and maintenance charges.

Office has submitted the list of 334 allottees who have not paid their respective license fees for various periods, out of which, 30 allottees are those who have not paid the license fees for the last two years and more.

It is jointly submitted by Sh. Rajpal Kasana, President, and Sh. Vipin Chowdhary, Secretary, Saket Bar Association that some time may be given to those defaulters to clear the arrears.

After deliberations, it is unanimously resolved that :

(i) those allottees of chambers/slots who have not paid the license fee and maintenance charges of their respective chambers/slots for more than two years or more, final notice be issued to them by the Office with directions to clear the arrears within a week from the date of receipt of the notice, failing which the allotment of respective chamber / slot will stand cancelled.

(ii) those allottees of chambers/slots who have not paid the license fee and maintenance charges of their respective chambers/slots for a period of more than six months and up to two years, notice be issued to them by the Office with directions to clear the arrears within 15 days from the date of receipt of the notice, failing which the

allotment of respective chamber / slot will stand cancelled.

(iii) those allottees of chambers/slots who have not paid the license fee and maintenance charges of their respective chambers/slots for a period of six months, notice be issued to them by the Office with directions to clear the arrears within a month from the date of receipt of the notice.

18. **i) Non – payment of penalty amount of Rs. 2200/- regarding dishonoring of two cheques of Sh. Ram Deo Maurya allottee of Chamber No. 777 (Single Occupancy)**
 ii) Representation dated 08.02.2016 of Sh. R.D. Maurya, allottee of ch. no. 777 for waiving of penalty amount of dishonored cheques as he has deposited License Fees and Maintenance Charges till March, 2017.

Discussed.

Pursuant to the request made by Sh. Karnail Singh, the then Hony Secretary, Saket Bar Association vide letter dated 21.03.2013, a decision was taken on 23.03.2013 by the then Ld. District & Sessions Judge (South) after consulting Sh. R.P. Kasana and Sh. Karnail Singh, the then President and Secretary respectively that the allottees Lawyers Chambers at Saket Courts, New Delhi have been allowed to pay/deposit license fee and maintenance charges in respect of the chamber under their allotment by way of demand draft / account payee cheque which, however must be drawn from the personal account of the allottee subject to the condition that in case, the cheque is dishonoured, the allottee shall be treated as a defaulter with liability for all consequences to flow including imposition of penalty (equivalent to one month's license fee) and cancellation of the allotment in terms of Allotment Rules and undertaking. The aforesaid decision was communicated to the Hony Secretary, Saket Bar Association vide letter dated 03.04.2013.

In view of the above decision, the penalty imposed regarding dishonouring of the cheque (s) cannot be waived off. Accordingly, the requests are declined. Office is directed to ask the allottees to deposit the penalty amount.

19. **(i) Representation dated 02.12.2015 of Sh. Joginder Singh, Advocate allottee of chamber no. 361 (double occupancy basis) regarding adding name of his spouse Ms. Reema Singh in the allotment order / letter as joint allottee.**

Fresh Matter

(ii) Representation dated 13.02.2016 of Sh. Joginder Singh, Advocate intimating that he has been appointed in District Judge Cadre in Madhya Pradesh and his enrollment of Bar Council of Delhi has been suspended.

He has further informed that he is allottee no. 2 of Ch. No. 361 and he has already applied for adding name of his spouse Ms. Reema Singh in the allotment order / letter as joint allottee vide rpt. dtd. 02.12.2015.

The rpt. is pending consideration before the Lawyers Chamber Allotment Committee.

(iii) Representation of Sh. Yogesh Baisoya dated 19.10.2015 informing that Sh. Joginder Singh has been appointed as ASJ in Madhya Pradesh for taking further action against this Chamber.

Discussed.

It is unanimously resolved that before taking decision, Ms. Reema Singh, wife of allottee Mr. Joginder Singh be asked to furnish the certificate of her membership, issued by the Bar Council of Delhi as well as Saket Bar Association.

20. Representation dated 19.10.2015 of Sh. Yogesh Baisoya intimating that Sh. Yogesh Kaushik allottee of Chamber no. 601 has been appointed as a Legal Advisor in DDA and for taking further action in the matter.

The Office has reported that comments of Mr. Mukesh Kaushik and Hony Secretary, Saket Bar Association were called.

In response, Mr. Mukesh Kaushik has submitted the comments vide letter dated 07.01.2016 intimating that he has not joined any government service either in part or full time. The Hony Secretary, Saket Bar Association has submitted comments vide letter dated 05.03.2016 informing that Chamber no. 601 is not allotted to Mr. Yogesh Kaushik and this Chamber has been allotted to Mr. Mukesh Kaushik and Mr. Romesh Kumar Joshi.

Discussed.

In view of the reply dated 07.01.2016 of Mr. Mukesh Kaushik and reply of Hony Secretary, Saket Bar Association dated 05.03.2016, the representation of Mr. Yogesh Baisoya dated 19.10.2015 calls for no further action. Accordingly, this issue may be deleted from the agenda.

21. Regarding payment of dues by Sh. Vikas Goyal (Allotment already canceled) and surrendering the possession of chamber no. 671.

It is noticed by the members of the Committee that as per decision taken in the meeting of LCAC held on 30.06.2015 & 05.08.2015, notice was sent to Sh. Vikas Goyal on 11.08.2015 as he has not deposited the dues of license fees and maintenance charges till 11.08.2015. The possession was taken over by the PWD. Till date, he has not cleared the dues and notice sent by Registered Post has been received back with the remarks 'left'.

Discussed.

It is unanimously resolved that the Bar Council of Delhi be requested to direct Mr. Vikash Goyal to deposit the dues of license fees and maintenance charges immediately, while also initiating steps for recovery of the dues as arrears of land revenue.

22. (i) Representation dated 18.03.2015 of Sh. Karamveer Singh for reviewing the earlier decision i.e. Rejection of his representations and allotment of chamber under initial allotment process. Application no. 638.

(ii) Another rpt. dtd. 20.01.2016 along with copy of the order passed by the Hon'ble High Court of Delhi in W.P. (C) No. 391/2016 titled Karamvir Singh Vs.

Lawyer's Chamber Allotment Committee anrs. on 15.01.2016 submitted by Mr. Karamvir Singh with a request to decide his rpt. dtd. 18.03.2015.

Discussed.

In view of the directions of the Hon'ble High Court of Delhi in Writ Petition No.391/2016 titled as Karamvir Singh Vs. Lawyer's Chamber Allotment Committee & Anr dated 15.01.2016, the matter relating to allotment of chamber to Mr. Karamvir Singh has been taken up for consideration. From the original papers that have been submitted by Mr. Karamvir Singh, it is noticed by the Committee that he is practicing since 2007 and has submitted 14 numbers of appearances and proved being in practice from the period 2007 to 2010. It is also noticed from the record that delay in submitting the records, has been on the ground of serious illness of the father of the applicant which is reflected from the medical records submitted by the applicant along with his application for extension of time dated 17.12.2012. These circumstances do appear to be true and the delay that occurred in submission of documents appears to have been due to circumstances beyond the power of Sh. Karamvir Singh. From the record, it is also observed that the father of the applicant had fallen ill immediately after the notice was issued calling the records.

The Committee is of the unanimous view that the case of Sh. Karamvir Singh deserves to be reconsidered in view of his documents establishing he was fulfilling all norms at the time of the initial allotment and the delay being on account of the serious illness of his father. The Committee unanimously resolves that the application of Mr. Karamvir Singh be accepted for allotment of chamber under the NDBA quota at the first availability of slot in the double occupancy of the chambers.

23. **i) A representation dated 13.10.2016 of Sh. Sidhartha Mohan, Advocate requesting to delete his old enrollment no. S-1604 in the record and use his original membership no. S-964 in all records including chamber allotment application and consider his application for chamber as per eligibility in old list.**

ii) A representation dated 13.02.2017 of Sh. Sidhartha Mohan, Advocate on the same ground as at (i) for consideration of his application in the process of Initial Allotment.

iii) A rpt. dated 02.03.2017 has been received from Sh. Sidhartha Mohan, Advocate for allotment of chamber in Saket Court Lawyers Block on the basis of seniority in NDBA and for necessary change in applicant's Saket Bar Association Membership.

Mr. Sidhartha Mohan has filed a Writ Petition (C)No. 2296/2017 titled Sidhartha Mohan Advocate Vs. Saket Bar Association & Ors and Vide order dated 10.03.2017 Hon'ble High Court of Delhi has directed that till the next date of hearing if there is a slot/chamber vacant, the same shall be kept reserved and not allotted.

This issue is deferred for consideration as the Hon'ble High Court of Delhi vide order dated 10.03.2017 has directed that till the next date of hearing i.e. 28.04.2017, if there is a slot/chamber vacant, the same shall be kept reserve and not allotted. The next date of hearing in the aforesaid Writ Petition is 15.11.2017.

24. **Representation of Sh. Bishnu Prasad Tiwari, Advocate for considering his name for allotment of chamber in the process of Initial Allotment.**

This issue is deferred for consideration in the next meeting.

25. **Representation dated 30.04.2016 of Ms. Khalida Masroor informing that due to illness she could not deposit the monthly fees of chamber no. 562, Saket Court Complex, New Delhi since November 2015 and requested to give sufficient time for depositing the same. She has deposited the Licence Fees & Maintenance Charges till June, 2016.**

Discussed.

It is unanimously resolved by the Committee that two weeks time be granted to Ms. Khalida Masroor to deposit the up to date arrears of license fees and maintenance charges. Office is directed to communicate the decision to the applicant.

26. i) (a) **Complaint against each other by both allottees namely Sh. Mohd. Nauman Khan against Sh. Mohd. Sarvar and Sh. Mohd. Sarvar against Sh. Mohd. Nauman Khan both allottee of chamber no. 354. The Lawyer's Chamber Monitoring Committee has sent the papers of the complaints for change of slot of Mr. Nauman Khan Advocate to another chamber and more preferably slot in chamber no. 483.**

b) **An undated application of Mohd. Nauman Khan for change of chamber from change of chamber no. 354 to ch. no. 483.**

ii) **A representation dated 03.11.2015 of Sh. Vikram Gola allottee of chamber no. 683 (double occupancy) for change of chamber no. 683 to chamber no. 506 or 515.**

iii) **A representation dated 26.07.2016 submitted by Mr. Inder Singh Allottee of chamber no. 670 and Mr. Paras Ram Sharma, Allottee of chamber no. 701 for mutual change of their chamber.**
