

MINUTES OF THE MEETING OF THE LAWYER'S CHAMBERS ALLOTMENT COMMITTEE, SAKET COURTS HELD ON 09.03.2018 IN THE CONFERENCE HALL, 3rd FLOOR, SAKET COURT COMPLEX, NEW DELHI.

I Subsequent Allotment

(A) Representations of Ineligible Applicant Lawyers:-

1. Representation dated 11.01.2018 of Mr. Babu Malayil, Advocate.

2. Representation of Mr. Bhanu Pant, Advocate.

It is noticed by the Committee that in the last meeting held on 16.01.2018, the Member Secretary, LCAC was requested to scrutinize the documents of Mr. Babu Malayil, Advocate and Mr. Bhanu Pant, Advocate.

The report has been submitted by the Member Secretary in a sealed envelope. Same has been opened and no changes in the status of Mr. Babu Malayil has been found. He does not meet the criteria prescribed or expanded by the Committee as he has 12 cases and 03 vakalatnamas.

The representation of Mr. Bhanu Pant will be taken in Agenda Item No.9.

3. Representation dated 08.02.2018 of Mr. Rakesh Kumar, Advocate.

Since the representation of Mr. Rakesh Kumar, Advocate has been submitted beyond the prescribed time limit i.e. 18.11.2017, the Committee is of the unanimous view that it cannot be considered. Hence it is unanimously resolved that his representation be rejected and be filed. He be informed.

4. Representation of Mr. Krishan Paul.

The representation of Mr. Krishan Paul, Advocate has been considered by the Committee whereby it is submitted that he has filed vakalatnama having his signature alongwith signature of his wife and so same should be considered as single signature and he be allotted a chamber.

It is unanimously resolved that Member Secretary, LCAC may confirm whether the vakalatnama is of the wife of the applicant by confirming the identity of the person who has signed the vakalatnama and submit a report in the next meeting. The Office shall call the documents from applicant to establish the identity of his wife and place the same before the Member Secretary, LCAC. The Executive of the Bar may also submit a report in this regard.

5. Representation dated 16.02.2018 of Mr. Sanjeev Kumar Sharma, Advocate.

Since the representation of Mr. Sanjeev Kumar Sharma, Advocate has been submitted beyond the prescribed time limit i.e. 18.11.2017, the Committee is of the unanimous view that it cannot be considered. Hence it is unanimously resolved that his representation be rejected and be filed. He be informed.

6. Representation dated 20.02.2018 of Mr. Vishal Singh, Advocate.

Since the representation of Mr. Vishal Singh, Advocate has been submitted beyond the prescribed time limit i.e. 18.11.2017, the Committee is of the unanimous view that it cannot be considered. Hence it is unanimously resolved that his representation be rejected and be filed. He be informed.

(B) Writ Petitions:-

7. Writ Petition filed by Ms. Reena Jain Malhotra, Advocate.

It is apprised by the office that the Writ Petition filed by Ms. Reena Jain Malhotra, Advocate has been dismissed by the Hon'ble High Court of Delhi vide order dated 12.01.2018. Since the Writ Petition has been dismissed, no further action is required in the matter and the same be deleted from the agenda.

8. Writ filed by Ms. Hnunpuui, Advocate.

It is noticed by the Committee that vide order dated 30.01.2018 in Writ Petition No.831/2018, the Hon'ble High Court directed to ensure that at least one cubicle in any one of the Multiple Chambers will be kept vacant till the next date of hearing i.e. 09.05.2018. Furthermore, it is also directed that in case possession is not given of chambers which are allotted on dual basis, the allotment, if any, will be subject to the final orders passed in the Writ Petition.

The Office is directed to note these directions and to record that the allotments henceforth shall be subject to the final orders passed in the WP (Civil) No.831/2018.

9. Writ Petition No. WP (C) 11180/2017, filed by Mr. Manoj Kumar Singh & Ors. (Including Mohd. Shankeel Khan, Mr. Nanak Chand Saini, Mr. Partheshwar Giri Gorakh, Mr. Om Prakash, Mr. Arun Kaushal, Ms. Sangita, Mr. Rahul Jain, Mr. Yogesh Sharma, Mr. Bhanu Pant & Mr. Kausar Akhtar Khan).

The Writ Petition was filed initially by the Mr. Manoj Kumar Singh & Ors. (Including Mohd. Shankeel Khan, Mr. Nanak Chand Saini, Mr. Partheshwar Giri Gorakh, Mr. Om Prakash, Mr. Arun Kaushal, Ms. Sangita, Mr. Rahul Jain). The applications of Mr. Yogesh Sharma, Mr. Bhanu Pant & Mr. Kausar Akhtar Khan were allowed and they were impleaded as petitioners by orders of the Hon'ble High Court.

In the said Writ Petition, the counsel for the Applicants/Petitioners submits that they would like to take the benefit of the judgment passed in WP (C) 11084/2017 titled Shoeb Shakeel Vs. Lawyers' Chambers Allotment Committee & Anr.

The Hon'ble High Court dismissed the petition in view of the these submissions of the Counsel, with the liberty to approach the Lawyers' Chambers Allotment Committee in accordance with the extant guidelines. It was also made clear that the Hon'ble Court had not examined the veracity of the assertions made on behalf of petitioner.

Representation were received thereafter from Mr. Bhanu Pant, Mr. Kausar Aktar Khan, Mr. Arun Kaushal, Mr. Yogesh Sharma, Mohd. Shakeel Khan, Mr. Om Prakash, Mr. Partheshwar Giri Gorakh and Mr. Manoj Kumar Singh. They were called for personal hearing at this meeting. Two advocates Ms. Sangeeta and Mr. Rahul Jain, who were applicants before the Hon'ble High Court within Writ Petition but were unable to file their representation, were also called by this Committee.

i). Representation dated 02.02.2018 of Mr. Bhanu Pant, Advocate.

Mr. Bhanu Pant, Advocate has been invited to explain his grievance. On scrutiny of the documents i.e. 14 cases & 03 vakalatnama originally submitted by him, it is found by the Committee that in complaint case no.966/2010, Jindle Sanitary & Hardware Vs. Silver Marx, besides vakalatnama bearing multiple signatures, Mr. Bhanu Pant had filed certified copy of final order of the case. Mr. Bhanu Pant has identified the complainant when he had made a statement before the Court acknowledging the settlement. The Committee is therefore, of the unanimous view that on parity with the orders passed by the Hon'ble High Court of Delhi in WP (C) No.11084/2017 titled as Shoeb Shakeel Vs. Lawyers Chambers Allotment Committee, the representation of Mr. Bhanu Pant can be allowed.

In view of abovesaid observations, the representation of Mr. Bhanu Pant, Advocate has unanimously been accepted. Office is directed to place the seniority of Mr. Bhanu Pant, Advocate in the light of the abovesaid decision to consider allotment of chamber to him.

ii). Representation dated 01.02.2018 of Mr. Kausar Aktar Khan, Advocate.

Mr. Kausar Aktar Khan, Advocate has been invited and he personally examined his documents originally submitted by him with his application. He has not been able to show any error in the decision of the LCAC/ Sub-Committee that he has not satisfied the prescribed criteria as his application was annexed with certified copies of documents in bail applications of same FIR. These have to be considered as one case.

Mr. Kausar Aktar Khan has been apprised of the order of the Hon'ble High Court passed in WP (C) 216/2018 titled Reena Jain Malhotra Vs. Lawyers Chambers Allotment Committee & Anr. observing that the Lawyers' Chambers Allotment Committee had rightly considered four cases as singular case as they were bail applications relating to the same FIR.

Since Mr. Kausar Aktar Khan, Advocate has failed to fulfill the eligibility criteria, his representation has been duly considered and the Committee unanimously rejects the same.

iii). Representations dated 01.02.2018 & 20.02.2018 of Mr. Arun Kaushal, Advocate.

Mr. Arun Kaushal, Advocate did not turn up despite invitation. However, the Committee rescrutinized his application and found that there is no change in status. His documents disclose that he is main counsel in only 10 cases and other 05 documents submitted by him do not show his appearance. The documents enclosed with his application do not establish any parity with the facts in WP (C) No.11084/2017 titled as Shoeb Shakeel Vs. Lawyers Chambers Allotment Committee. Accordingly, his representations are unanimously rejected by the Committee.

iv). Representations dated 05.01.2018 and 21.02.2018 of Mr. Yogesh Sharma, Advocate.

Mr. Yogesh Sharma has appeared before the Committee and has personally scrutinized the documents submitted by him at the time of filing of his application. The Committee also scrutinized the same and finds that he has submitted 14 cases and one vakalatnama. But the vakalatnama submitted by Mr. Yogesh Sharma, Advocate cannot be considered due to multiple signatures. Since the applicant has not been able to show parity of his case with the facts in WP (C) No.11084/2017 titled as Shoeb Shakeel Vs. Lawyers Chambers Allotment Committee nor has he fulfilled the eligibility criteria, his representations are unanimously rejected by the Lawyers' Chambers Allotment Committee.

v). Representation dated 17.02.2018 of Mohd. Shakeel Khan.

Mohd. Shakeel Khan has been called and he expressed his grievance. He has explained the documents submitted by him to show parity with the facts in WP (C) No.11084/2017 titled as Shoeb Shakeel Vs. Lawyers Chambers Allotment Committee. In view of the same, Committee unanimously decided to consider his representation on the parity with the case of Shoeb Shakeel. The office is directed to place him accordingly his seniority, for consideration of allotment of chamber to him.

vi). Representation dated 06.02.2018 of Mr. Om Prakash, Advcoate.

Representation dated 19.02.2018 of Mr. Partheshwar Giri Gorakh, Advocate

Representation dated 19.02.2018 of Mr. Manoj Kumar Singh, Advocate.

All the three applicants have appeared turn-wise, in person. Since all the said applicants even after personally scrutinizing the documents submitted along with their applications, have not been able to show their eligibility as also the parity of their case with facts in WP (C) No.11084/2017 titled as Shoeb Shakeel Vs. Lawyers Chambers Allotment Committee, their representations have been duly considered by the Committee and unanimously rejected.

10. Writ Petition filed by Pawan Kumar Jha along with representation dated 16.02.2018

The Committee has been apprised that the Writ Petition filed by the applicant has been disposed of vide order dated 05.02.2018 with the direction to the Lawyers' Chamber Allotment Committee i.e. Respondent No.1 to treat the present Writ Petition as a representation and dispose of the same with a reasoned order expeditiously within six weeks. The applicant was invited in the meeting.

The matter has been deferred as the applicant has been asked to supply the copy of Writ Petition filed by him in the Hon'ble High Court of Delhi so that it can be taken up for consideration in the next meeting.

11. (a). Writ Petition No.89/2018 titled as Bijay Kumar Vs. LCAC

It is noted by the Committee that the said Writ Petition was dismissed vide order dated 31.01.2018 for non-prosecution. No further action is required in the matter and hence same be deleted from the agenda.

(b). Representation dated 20.01.2018 of Mr. Bijay Kumar.

With regard to the representation filed by Mr. Bijay Kumar, Advocate, the Committee finds that even on scrutiny, he does not meet the eligibility criteria. Hence his representation is rejected by the Committee unanimously.

12. Writ Petition filed by Mr. Jagat Singh Nagar along with representation dated 20.02.2018.

As per the directions of the Hon'ble High Court, the copies of his application form along with annexures were supplied to him. He submitted a representation dated 20.02.2018. However, on rescrutiny by the Committee, it is clear, he does not fulfill the eligibility criteria as in two cases, he did not annexe any documents in support and in the 3rd case, the documents filed are from the court of Deputy Commissioner/Collector. In a 4th case, he submitted the vakalatnama with multiple signatures. Since he does not fulfill the eligibility criteria having only 11 valid "cases", his representation is unanimously rejected by the Committee.

(C). Representation of Eligible Applicant Lawyers:-

13. Representation dated 03.02.2018 of Mr. Rajnish Kumar, Advocate.

It is informed by the office that in view of the decision taken vide minutes of meeting held on 05.09.2017, seniority list was prepared as per SBA and seniority in enrolment. As per the seniority list of SBA, the seniority of applicant lawyer is 00393. Date of Membership of SBA of the applicant is 01.12.2010 i.e. common date of registration for founder members. The date of Membership of BCD is 18.12.2014.

It is further reported that advocate whose name is reflected immediately above the name of Mr. Rajnish Kumar i.e. Mr. Sumit Khari is also a founder Member with date of SBA

membership is 01.12.2010. But the date of registration with BCD is 30.11.2014. The advocate whose name is mentioned immediately below Mr. Rajnish Kumar i.e. Mr. Azad Ali is also a founder Member and date of SBA membership is 01.12.2010. But his registration with BCD is 15.02.2015.

Accordingly, the date of SBA membership being the same i.e. 01.12.2010, the seniority in the list is placed as per registration with BCD. The Committee finds that there is no error in the said list and also unanimously rejects the representation of Mr. Rajnish Kumar.

(D). Representation with regard to List D-21.

14. (a) Complaint dated 18.12.2017 of Mr. Rajeev Verma, Advocate.

Complaint dated 18.12.2017 received from Mr. Rajeev Verma, Advocate objecting offer of allotment given to applicant lawyers namely Mr. Braham Prakash Dhalla, Mohd. Asif, Mr. Kamal Deep and Mr. Ashok Kumar Kotnala in List D-21, was considered by the Committee in the meeting held on 16.01.2018 and the response of advocates were directed to be called.

However, on 13.02.2018, Mr. Rajeev Verma, Advocate has withdrawn his complaint dated 18.12.2017. No further action is required in the matter and hence same be deleted from the agenda.

(b). Joint complaint dated 18.12.2017 of Mr. Krishan Pal Baisoya, Mr. Rajesh Kumar and Mr. Vinod Kumar against Mr. Ashok Kotnala, advocate.

With regard to complaint against Mr. Ashok Kotnala, response has been received from him whereby he submitted that he had only a seat in the B.S. Mehta Square, Patiala House Courts, which was transferred to Mr. Parveen by the NDBA. It was also submitted that seat in the B.S. Mehta Square, Patiala House Court has not been considered as chamber.

Since the seat has not been considered as chamber, there is no weight in the joint complaint against Mr. Ashok Kotnala, Advocate and hence the Committee unanimously resolved to reject the same.

15. Complaint dated 01.02.2018 of Mr. Vinod Kumar Sharma, Advocate against Mr. B.R. Sharma, Advocate

It is noticed by the Committee that an earlier complaint dated 15.12.2017 was considered by the Committee in its meeting held on 16.01.2018 and it was unanimously resolved that since Mr. B.R. Sharma has not given his response to the notice of offer of allotment in the prescribed time, no further action was called.

Now it is apprised to the Committee by the office that Mr. B.R. Sharma, Advocate has submitted his acceptance letter and affidavit on 20.02.2018 although the last date for submission of said acceptance for chamber allotment was 19.12.2017. It is further informed by the office that LCAC vide minutes dated 16.01.2018 has rejected candidature of Mr. B.R. Sharma, Advocate and offered allotment to the next senior in the eligibility list.

Since the candidature of Mr. B.R. Sharma has already been rejected by the Committee when no acceptance was submitted by him, the Committee unanimously resolves that now his belated acceptance cannot be held to be valid and further resolves that Mr. B.R. Sharma cannot be allotted a chamber. The fresh complaint of Mr. Vinod Sharma dated 01.02.2018 calls for no further action accordingly, as his grievance has been addressed.

16. Representation of Mr. Naushad Ali for change of chamber.

Mr. Naushad Ali, 2nd allottee of Chamber No.534 has requested to change his chamber to a lower floor due to age factor and difficulty in climbing the stairs.

It is informed by the office that first slot in chamber in 257 is available for allotment. Hence it is unanimously resolved that chamber No.257 be allotted to Mr. Naushad Ali on double occupancy basis. Accordingly **List E-28** (Subsequent Allotment) has been prepared and same be published as per past practice.

17. Representation of Mr. Ashish Kumar Sharma, Advocate, allottee of Chamber No.437.

The representation for change of chamber of Mr. Ashish Kumar Sharma, allottee of Chamber No.437 to chamber No.711 has been considered by the Committee. Mr. Ashish Kumar Sharma has also enclosed the consent of 1st allottee in Chamber No.711.

The office has informed that 2nd slot in Chamber No.711 is allotted to Ms. Vandana Kehlon, who has not given any consent to change of her chamber.

Hence the representation of Mr. Ashish Kuamr Sharma cannot be considered for want of consent from Ms. Vandana Kehlon.

18. Representation of Ms. Pooja Bhasin, Advocate, 1st allottee of chamber No.455 for change of chamber of her co-allottee

Mr. Pooja Bhasin 1st allottee of chamber No.455 has requested that Ms. Suman Sharma be allotted chamber No.786 in place of Ms. Mir Baby Lal the 2nd allottee in that chamber and allot 2nd slot in chamber No.455 to Ms. Mir Baby Lal in place of her co-allottee Ms. Suman Sharma.

The office has reported that Ms. Mir Baby Lal has not given any consent to change her chamber. Office has put up a letter dated 09.03.2018 received from Ms. Suman Sharma, Advocate requesting for change of her chamber or for permission to partition her presently allotted Chamber no.455 on double occupancy basis.

After extensive discussions, it is unanimously resolved by the Committee that a vertical temporary wooden partition be created in chamber No.455 under the supervision of Asstt. Engineer (Civil), PWD, the Caretaker and Mr. P.K. Saxena, Branch In-Charge (LCAC) to divide it equally between the two allottees of chamber No.455. It is further made clear to the allottees that the cost of partition would be recovered from both the allottees.

The office has apprised the Committee that there are adjustment problems between Ms. Sangeeta Batra and Ms. Ritu Mishra, Allottees of Chamber No.644, who have made allegations against each other. It is unanimously resolved that a vertical temporary wooden partition be also created in chamber No.644 under the supervision of Asstt. Engineer (Civil), PWD, the Caretaker and Mr. P.K. Saxena, Branch In-Charge (LCAC) to divide the chamber equally between the two allottees. The Committee unanimously resolves that the cost of partition would be recovered from all the allottees in these two chambers. .

19. Representation dated 16.02.2018 of Mr. Rakesh Kumar Sachdeva for change of chamber.

Representation was considered. Since no reasonable grounds are found for effecting a change of chamber, the representation of Mr. Rakesh Kumar Sachdeva is unanimously rejected by the Committee.

20. Representation dated 20.02.2018 of Ms. Neelam for change of chamber.

Ms. Neelam has requested to change her chamber from 817 to chamber No.654 and she has also enclosed the NOC of Mr. Dinesh Prasad, 2nd allottee in chamber No.654.

The Office has reported that 1st slot in Chamber No.654 is available for allotment due to demise of allottee, hence the request of Ms. Neelam is accepted and she has been allotted chamber No.654 on double occupancy basis. Accordingly her name be incorporated in **List E-28** (Subsequent Allotment).

21. Representation dated 22.02.2018 of Mr. Kalimur Rehman for change of chamber.

Representation was considered. Since no reasonable grounds are found for the change of chamber, the representation of Mr. Kalimur Rehman is unanimously rejected by the Committee.

22. Joint representation of Mr. Arzoo Kamal and Mr. Sher Afgon for change of chamber.

Joint representation of both the Advocates has been considered by the Committee and unanimously allowed. Accordingly they are allotted Chamber No.850 on double occupancy basis.

Since Mr. Arzoo Kamal was 1st allottee in chamber No.535 and was allotted chamber in Initial Allotment, he has been allotted 1st Slot of Chamber No.850 and the slot will be treated as Initial Allotment. Similarly, since Mr. Sher Afgon was 1st allottee in Chamber No.671 and was allotted chamber in Subsequent Allotment, he has been allotted 2nd Slot in Chamber No.850 and the slot will be treated as Subsequent Allotment.

Accordingly, **List E-29** (Initial Allotment) is prepared & name of Mr. Arzoo Kamal, Advocate is incorporated therein. Name of Mr. Sher Afgon has been incorporate in **List E-28** (Subsequent Allotment).

23. Complaint dated 01.02.2018 of Mr. Wazir Haider Zaidi, Advocate against allotment of chamber to Mr. J.C. Kaushik, Advocate.

After discussion, since Committee does not find any merit in the complaint, same has been unanimously rejected.

II. Initial Allotment:-

24. Representation of Mr. Sidhartha Mohan regarding allotment of chamber.

Deferred.

25. Representation of ineligible applicants

Deferred.

26. Vacant Chamber:-

Vacancy report submitted by the office is noted by the Committee.

It is noticed by the Committee that vide representation dated 09.02.2018, Ms. Vimmi Mahant, Advocate 2nd allottee of chamber No.676 has requested for change of chamber from 676 to 330. She has also enclosed the consent of Mr. Rajesh Kumar Patoha, Advocate, 1st allottee of Chamber No.330.

The office has reported that one slot in chamber No.330 is available for allotment on double occupancy basis. The Members of the Committee unanimously resolve to allot the 2nd slot in chamber No.330 to Ms. Vimmi Mahant, Advocate in view of the 2nd slot in chamber No.676 (on double occupancy basis) already allotted to her.

It is also noticed by the Committee that in meeting held on 16.01.2018, the office has reported that one slot in Chamber No.330, on double occupancy basis, (now one slot in chamber No.676 after allowing the request of Ms. Vimmi Mahant) and one slot in Chamber No.666 are available for allotment under Initial Allotment. In order to save the time, the office was directed to inform the next six senior most persons as reflected in list C-1 (under the Initial Allotment) to submit the application as per format along with requisite documents and to place the same for further decision before the Committee in the next meeting.

In this regard the office has reported that letters of offer was sent to Ms. Vineeta Narender Kumar, Mr. Amit Kumar Basoya, Mr. Rajesh Kumar, Ms. Bhaswati Anukampa, Mr. Muqeem Ahmad and Mr. Mukesh Chand Sharma.

However, in response, documents have been received from Mr. Amit Kumar Basoya, Mr. Rajesh Kumar & Mr. Muqeem Ahmad only, whereas, the letter sent to Ms. Vineeta Narender Kumar at the two addresses provided by her have been received back unserved with the remarks of postman, "Addressee left without address" and "No such person in address" and the letter sent through Process Server has also remained unserved.

Letter sent to Ms. Bhaswati Anukampa, Advocate and Mr. Mukesh Chand were duly served through Process Server. However, no documents have been received from them yet.

The Office has reported that one Chamber No.666 which was earlier reported to be on double occupancy basis is actually a single occupancy chamber.

After discussions it is unanimously resolved that Chamber No.666 be reserved under the category of Retired Judicial Officer and one slot earlier reserved under that category i.e. one slot in chamber No.780 be made available for allotment to advocates in general category.

Office has also put up vacation report of Ist slot in Chamber No. 562 (Double Occupancy Basis) and Ist slot in Chamber No. 654 (Double Occupancy Basis) now one slot in chamber No.817 after allowing the request of Ms. Neelam in item No.20. Same be taken on record.

Consequent thereof four slots were available for allotment to applicant lawyers of "Initial allotment" phase.

In these circumstances, the committee unanimously resolves to offer them allotment of 2nd slot in chamber No.751(Double Occupancy Basis) to Mr. Amit Kumar Basoya (NDBA No.3821), 2nd slot in Chamber No.676 (Double Occupancy Basis) to Mr. Rajesh Kumar (NDBA No.3824) and 2nd slot in Chamber No. 562 (Double Occupancy Basis) to Mr. Muqeen Ahmad (NDBA No.3829). Accordingly, **List D-23** (Initial Allotment) prepared and be published as per past practice.

For remaining one slot office is directed to inform the next three senior most persons as reflected in list C-1 (under the Initial Allotment) to submit the application as per format along with requisite documents and to place the same for further decision before the Committee in the next meeting.

27. Representation dated 06.07.2017 of Mr. Naresh Kumar, Advocate 1st allottee of Chamber No.216 .

Since no chamber has been left on single occupancy basis, the representation of Mr. Naresh Kumar, Advocate be filed and same be deleted from the agenda.

28. Letter of Mr. Karan Saluja, Advocate.

Letter of Mr. Karan Saluja, Advocate has been considered by the Committee whereby he requested transfer of Chamber No.219 in his name which was allotted to Mr. Rajan Saluja who has passed away.
