MINUTES OF THE MEETING OF THE LAWYER'S CHAMBERS ALLOTMENT COMMITTEE, SAKET COURTS HELD ON 16.05.2018 IN THE CONFERENCE HALL, 3rd FLOOR, SAKET COURT COMPLEX, NEW DELHI.

Mr. Girish Kathpalia, Ld. District & Sessions Judge (SE) has informed that he is attending a meeting in his District and is unable to attend.

1. Representation of Mr. Krishan Paul, Advocate for allotment of chamber.

It is informed by Mr. Atul Krishan Agrawal, Member Secretary of the Committee that he thoroughly inspected the documents submitted by the Applicant and found that the applicant had submitted seventeen certified copies. Out of these, documents in seven cases fall within the category of "cases" in terms of the norms approved vide minutes of meeting dated 05.09.2017. Two cases are of the same parties supported with copy of vakalatnama signed with his wife Sanyogita, Advocate. Other four Vakalatnamas are signed along with his wife. Additionally, four vakalatnamas bear signature of applicant with some other Advocates and in one case only self attested copies have been filed.

The Members of the Committee have considered the representation and unanimously accepted the seven clear cases in which certified copies were filed, two cases which were of the same parties as filing nos. are different and four cases where the vakalatnamas are signed by the applicant with his wife. However, the one self attested copy of the case cannot be considered. The multiple vakalatnamas cannot be also accepted. As the total number of cases are 13, which does not fulfill the eligibility criteria, hence it is unanimously resolved to decline the representation of Mr. Krishan Paul. He be informed.

2. Representations dated 17.03.2018 of Mr. Yogesh Sharma, Advocate.

Mr. Yogesh Sharma, Advocate appeared in person and requested for taking additional documents. It is noticed by the Committee that vide minutes of meeting held on 09.03.2018, applicant had not been able to show the parity of his case with the facts in WP (C) No.11084/2017 titled as "Shoeb Shakeel Vs. Lawyers Chambers Allotment Committee". His request for submitting additional documents now cannot be accepted as no one has been granted such additional time including by the Hon'ble High Court to Shoeb Shakeel.

In his other representation he has requested for review of his application in view of orders in WP (C) No.11180/2017 titled as "Manoj Kumar & Ors. Vs. Govt. of NCT of Delhi & Ors". It is further requested by the applicant that one more chance for scrutiny of his submitted documents be given to him to prove that he was the Main Counsel in all the cases. The Committee unanimously resolved that Mr. Atul Krishan Agrawal, ACJ/Member Secretary be requested to deseal the almirah and scrutinize the documents earlier filed by the applicant, in the presence of the applicant and again re-seal the almirah and submit his report in the next meeting. The date of the inspection will be communicated to the applicant by the Member Secretary as per mutual convenience.

3. Representation dated 16.02.2016 of Mr. Pawan Kumar Jha for allotment of chamber.

It is noticed by the Committee that in the last meeting held on 09.03.2018, the applicant was asked to supply the copy of Writ Petition filed by him in the Hon'ble High Court of Delhi so that it could be taken up for consideration. However, neither Mr. Pawan Kumar Jha has turned up nor he has filed the copy of his Writ Petition. Matter be deferred for next meeting. Office is directed to send him notice for personal appearance. The office may also put up the copy of writ petition received at the office pursuant to notice issued in the writ petition to enable the committee to consider the matter in the next meeting.

4. Representation dated 16.04.2018 received from Mr. Aman Kumar Singh, Advocate.

Representation of Mr. Aman Kumar Singh, advocate has been considered by the Committee whereby he requested to reconsider his case.

Since it is noticed by the Committee that vide minutes of meeting, the last date for removal of objection was 18.10.2017 and the present representation was filed by the applicant only on 16.04.2018, the representation of Mr. Aman Kumar Singh cannot be considered and is unanimously declined. The same be filed. He be informed accordingly.

5. LPA 230/18, Jaya Goyal Vs. Lawyers Chamber Allotment Committee, filed before Hon'ble High Court of Delhi.

It is noticed by the Committee that vide order dated 09.05.2018 in LPA 230/18 titled Jaya Goyal Vs. Lawyers Chamber Alltoment Committee, the Hon'ble High Court has observed that the Lawyers Chambers Allotment Committee should consider the petitioner/appellant as eligible given that she fulfils other criteria. The Committee is further directed to process and decide the appellant's application on the basis that it fulfills the

relevant eligibility criteria.

In view of the said directions, status of Ms. Jaya Goyal is established as eligible applicant lawyer. Office is directed to place her according to her seniority in the list of eligible applicant lawyers. She be given provisional offer of allotment of chamber on Double Occupancy Basis. **List D-25 (Subsequent Allotment)** has been prepared and same be published as per past practice.

6. Joint representation of dated 06.04.2018 of Mr. Ashok Kumar Agarwal, Advocate and Mr. Rakesh Malhotra, Advocate for change of chamber.

The Joint representation of Mr. Ashok Kumar Agarwal, Advocate 1st allottee of Chamber No. 425 and Mr. Rakesh Malhotra, 2nd Allottee of Chamber No. 551 for allotment of one common chamber to them on double occupancy basis has been considered by the Committee.

It is informed by the office that both slots in Chamber No.849 are available for allotment. Hence it is unanimously resolved to allot Chamber No.849 to Mr. Ashok Kumar Agarwal and Mr. Rakesh Malhotra as 1st and 2nd allottee(s) respectively on double occupancy basis. Accordingly **List E-31** (Subsequent Allotment) has been prepared and same be published as per past practice.

7. Joint request for change of chamber received from Mr. Bharat Ahuja, Advocate and Md. Rashid, Advocate.

The Joint representation of Mr. Bharat Ahuja, Advocate 2nd allottee of Chamber No. 835 and Md. Rashid, Advocate 1st Allottee of Chamber No. 537 for allotment of one common chamber to them on double occupancy basis has been considered by the Committee. It is also noticed that they have given their preference to allot chamber No.862.

It is informed by the office that both slots in Chamber No.862 are available for allotment. Hence it is unanimously resolved to allot Chamber No.862 to Md. Rashid, Advocate and Mr. Bharat Ahuja, Advocate as 1st and 2nd allottee(s) respectively on double occupancy basis. Accordingly, **List E-30** (**Initial Allotment**) has been prepared and name of Mohd. Rashid is included in the same and the name of Mr. Bharat Ahuja is included in **List E-31** (**Subsequent Allotment**) and same be published as per past practice.

8. Request of Mr. Faiyaz Hasan, Advocate for change of chamber on lower floor.

Representation of Mr. Faiyaz Hasan, Allottee of Chamber No.847 has been considered by the Committee.

It is informed by the Office that one slot in chamber No.235 is available for allotment. Hence, it is unanimously resolved to allot $1^{\rm st}$ slot of Chamber No.235 to Mr. Faiyaz Hasan, Advocate on double occupancy basis. Accordingly, his name has

been incorporated in **List E-31 (Subsequent Allotment)** and same be published as per past practice.

9. Request of Mr. Hari Shanker Sisodia, Advcoate for exchange of chamber No.683 with chamber No.348.

Representation of Mr. Hari Shanker Sisodia, Allottee of Chamber No.683 for change of his chamber to 348 has been considered by the Committee. He also enclosed the NOC of Mr. S.U. Khan, Advocate, 2nd Allottee of Chamber No. 348.

It is informed by the Office vacancy report of one slot in Chamber No. 348 has been received recently through note from General Admn. Branch. Therefore, it is unanimously resolved to allot 1st slot of Chamber No.348 to Mr. Hari Shanker Sisiodia, Advocate on double occupancy basis. Accordingly, his name has been incorporated in **List E-31 (Subsequent Allotment)** and same be published as per past practice.

10. Allotment of Chamber of Mohd. Shakeel Khan, Advocate.

It is noticed by the Committee vide minutes dated 09.03.2018, the representation of Mohd. Shakeel Khan was allowed and office was directed to place his seniority in the list of eligible applicants.

The office has amended the seniority list and fixed the seniority of Mr. Shakeel Khan at S.No.39-A of list of eligible applicants. In these circumstances, the committee unanimously resolves to offer him chamber on double occupancy basis. Accordingly, name of the lawyer be included in **List D-25 (Subsequent Allotment)** and be published as per past practice.

11. Allotment of chambers to applicant lawyers Mr. Braham Prakash Dhalla, Mohd. Asif, Mr. Kamaldeep and Mr. Ashok Kotnala.

It is informed by the Office that all the above named applicants were offered provisional allotment in List D-21 and they have submitted their provisional acceptance for allotment of chamber but the allotment could not be made due to complaints made against them. However, it is noticed by the Committee that complaints against all the abovesaid applicants have been disposed of vide minutes of meeting held on 09.03.2018. Since the abovesaid applicants have already been provisionally offered chambers, their names be incorporated in **List E-31 (Subsequent Allotment)** and same be published as per past practice.

12. Allotment of Chambers to applicants included in List D-22.

It is informed by the Office that 11 (eleven) applicants have been offered provisional allotment vide List D-22 and all have given their acceptance. Allotment to applicants at S.No.10 & 11 of List D-22 is deferred in view of the decisions in agenda Item No.5 and 10 of these minutes. It is unanimously resolved to allot

Chambers to applicants at S.No.1 to 9 of List D-22 on double occupancy basis and their names be incorporated in **List E-31** (Subsequent Allotment). Same be published as per past practice.

13.(i) (a). Representation received from Ms. Pooja Bhasin, Advocate, 1st Allottee of Chamber No.455 (Allotted in Initial Phase) has requested to change the chamber of her Co-Allottee Ms. Suman Sharma (allotted in Subsequent Allotment Process) to some other Chamber.

(b). Representation of Ms. Suman Sharma regarding Chamber No. 455.

It is informed by Mr. Sanjiv Jain, Chairperson (LCMC) that matter has been resolved by erecting partition dividing the chamber into equal partition. Since the matter has been resolved, no further action is required in the matter and the same be deleted.

13 (ii). Complaints of each other by the Allottees of Chamber No.644.

It is observed by the Committee that in the minutes of meeting held on 09.03.2018, it was informed by the Office that there are adjustment problems between Ms. Sangeeta Batra and Ms. Ritu Mishra, Allottees of Chamber No.644, who have made allegations against each other and it was unanimously resolved that a vertical temporary wooden partition be created in chamber No.644 under the supervision of Asstt. Engineer (Civil), PWD, the Caretaker and Mr. P.K. Saxena, Branch In-Charge (LCAC) to divide the chamber equally between the two allottees. The Committee unanimously also resolved that the cost of partition would be recovered from all the allottees in these two chambers.

However, it is informed by the office that partition could not be made till date due to their adamant behaviour. It is unanimously resolved that the resolution passed in the meeting held on 09.03.2018 be executed. The Chairperson (LCMC) is requested to supervise the same through the officials aforementioned.

14. Representation dated 22.01.2018 of Mr. G.R. Sharma, Advocate.

It is apprised to the Committee that applicant had applied for allotment of chamber in the process of Initial Allotment and as he was not a member of NDBA, he was found ineligible for allotment of chamber at that time.

The Initial Allotment was for Members of NDBA who shifted to Saket Court and Mr. G.R. Sharma was not a Member of NDBA. In view of his ineligibility the committee declines his representation. Same be filed. He be informed accordingly.

15. Representation dated 24.01.2018 of Mr. Vijay Pal Bidhuri for allotment of Chamber.

Deferred.

16. Representation of Mr. Sidhartha Mohan regarding allotment of chamber.

It is noticed by the Committee that in the meeting held on 16.01.2018, the Ld. Administrative Civil Judge (South) was requested to scrutinize the application of Mr. Sidhartha Mohan. It is submitted by the ACJ that the application of Mr. Sidhartha Mohan was scrutinized and found to be eligible for allotment of Chamber on Double Occupancy Basis in the process of Initial Allotment.

The office is directed to process the application of Mr. Sidhartha Mohan for allotment of chamber and to place his seniority in the list of eligible applicant lawyers. He be given provisional offer of allotment of chamber in Double Occupancy Basis. Accordingly, **List D-24 (Initial Allotment)** has been prepared and same be published as per past practice.

17. Consideration on one vacant slot vacant for allotment under "Initial Allotment".

Taken up with agenda Item No. 19 of these minutes.

18 Consideration on the List D-23 for allotment of chambers to Applicants of Initial Allotment Phase.

It is noticed by the Committee that vide List D-23, published in compliance to minutes of meeting dated 09.03.2018 provisional offers of allotment were given to Mr. Amit Kumar Besoya Advocate, Mr. Rajesh Kumar, Advocate and Mr. Muqeem Ahmad, Advocate.

It is informed by the office that all the above three applicant lawyers have accepted the offer of allotment. Since all the formalities have been completed by the applicants, their names are incorporated in **List E-30**. Office is directed to publish the same as per past practice.

19. Vacation report of 1st Slot of Chamber No.348.

It is observed by the Committee that vide minutes of meeting held on 09.03.2018, the office was directed to inform the next three senior most persons as reflected in List C-1 (under Initial Allotment) to submit the application as per format along with requisite documents against the vacant slot reported in the minutes of meeting dated 09.03.2018 and to place the same for further decision before the Committee in the next meeting.

It is informed by the Office that letters were issued to Ms. Kiran Bharti (NDBA No.3841), Mr. Somnath Bharti (NDBA No.3845) and Mr. Rajender Singh Chauhan (NDBA) No.3855. However, out of these only Ms. Kiran Bharti has responded to the

letter but she has not submitted any documents of appearance before the Courts of South and South-East District(s).

The Members of the Committee are of the unanimous view that no further time can be granted to Ms. Kiran Bharti to file documents. Hence her candidature is unanimously rejected.

Further, it is informed by the office that report with regard to another vacant slot i.e. 1st slot of Chamber No.348 has been received from the General Admn. Branch and now it is available for allotment. The said slot has been allotted to Mr. Hari Shanker Sisodia vide agenda Item No.9 of these minutes. One vacant slot be taken on record for allotment against the applicants of chambers in Initial Allotment Phase.

The office is directed to inform the next six senior most persons against these two vacant slots, as reflected in List C-1 (under Initial Allotment) to submit the applications as per format along with requisite documents and to place the same for further decision before the Committee in the next meeting.

20. Letter of Mr. Karan Saluja, Advocate for transfer of Chamber No.219 earlier allotted to his deceased father Mr. Rajan Saluja.

It is noticed by the Committee that issue was discussed in the meeting held on 09.03.2018 and the letter of Mr. Karan Saluja, Advocate was considered whereby he requested to transfer of Chamber No.219 earlier allotted to his deceased father and the Hony. Secretary, SBA was requested to verify the same.

It is confirmed by the President & Hony. Secretary, SBA that Sh. Rajan Saluja has expired though as per record called from the Genl. Admn. Branch & Genl. Branch, no intimation has been received regarding death of Mr. Rajan Saluja, Allottee. However, as per past policy and in terms of Rule 27 of Allotment Rules, it is unanimously resolved that Chamber No.219 be transferred in the name of Mr. Karan Saluja, Advocate. The Office is directed to take the necessary steps.

21. Application of Mr. Harnam Singh Sharma for allotment of Chamber under Rule 8(ii) (Category reserved for Retired Judicial Officer)

Deferred.

22. Application dated 25.01.2018 of Mr. Rajeev Nandan Singh for allotment of chamber.

The application of Mr. Rajeev Nandan Singh for allotment of chamber under the reserved category of Physically Challenged Persons was considered by the Committee in the meeting held on 09.03.2018 and it was resolved that the same will be considered after due scrutiny.

In view of the report submitted by the Office as his disability certificate does not disclose permanent disability, hence his application cannot be considered under the reserved category for Physically Challenged Persons. Application of Mr. Rajeev Nandan Singh is unanimously declined and same be filed. He be informed accordingly.

23. Allotment of chamber to applicants under the Reserved Category of Physically Challenged Persons.

Pursuant to the offer earlier given for allotment of chamber (on double occupancy basis) to Satyevir Singh Grewal, Advocate, against reserved category of Physically Challenged Persons under Rule 8(i) of the Allotment Rules vide List FF1/G, as per decisions taken in the meeting held on 09.03.2018.

It is informed by the Office that acceptance and requisite documents have been submitted by the applicant pursuant to the resolution made in the meeting held on 09.03.2018. Accordingly **List GG-7** has been prepared and the same be published.

24. Representation dated 15.11.2017 of Mr. Wahid Hussain, Advocate, Allottee of chamber No.623.

As per report received from General Branch, Mr. Wahi Hussain has made payments of Licence Fee and Maintenance Charges from February, 2014 to June, 2016 only on 14.05.2018. The Committee expressed its displeasure. On the request of the President and Hony. Secretary, Saket Bar Association, further time of one month is granted to the allottee for making upto date payment. Upto date payment be made by 15.07.2018 and no further time will be granted.

25. Representation of Mohd. Sadiq, Advocate, 2nd Allottee of Chamber No.315.

As per report received from General Branch, Mohd. Sadiq has made payments of Licence Fee and Maintenance Charges till July, 2017 only on 14.05.2018. The Committee expressed its displeasure. On the request of the President and Hony. Secretary, Saket Bar Association, further time of one month is granted to the allottee for making upto date payment. Upto date payment be made by 15.07.2018 and no further time will be granted.

26. Representation of Mr. Shyam Phool Bhati, 2nd Allottee of Chamber No.485.

It is noticed by the Committee that allotment of Mr. Shyam Phool Bhati, 2nd Allottee in Chamber No. 485 was cancelled vide minutes of meeting held on 09.10.2017 due to non-payment of Licence Fee and Maintenance Charges of

chamber. Now, it is reported by the office the applicant has made payment upto February, 2018. Since the allottee has made payment upto February, 2018, it is unanimously resolved to restore his allotment in Chamber No.485 as 2nd Allottee. The Office is directed to do the needful.

27. Representation of Ms. Seema Gautam W/o Late Mr. Rakesh Gautam.

The office has put up a letter received from Ms. Seema Gautam W/o Late Mr. Rakesh Gautam whereby she requested for waiving off the Licence Fee and Maintenance Charges of Chamber No.654 allotted to her deceased husband Late Sh. Rakesh Gautam.

It is informed by the office that payment of licence fee was due w.e.f. April, 2017 and a letter was sent to the residence of the applicant to deposit the arrears. In response thereto, his wife Ms .Seema Gautam informed that applicant Mr. Rakesh Gautam has expired on 21.04.2017. It is apprised to the Committee that the said chamber has now been allotted to Ms. Neelam, Advocate vide minutes of meeting held on 09.03.2018.

In these circumstances as Late Sh. Rakesh Gautam had paid lisence fee till the month of his death, the representation of Ms. Seema Gautam W/o Late Mr. Rakesh Gautam has been unanimously allowed by the Committee and office is directed to intimate her accordingly.

28 (i) Cancellation of Chamber No.259

It is apprised to the Committee that the allotment of Chamber No.259 was cancelled as both the allottees namely Mr. Ram Baboo Sisodia and Ram Chandra Sisodia had not paid the Licence Fee and Maintenance Charges for the last more than $2\frac{1}{2}$ years. Now, it is informed that both the applicants have made payments upto May, 2018 though they have not requested for restoration of their allotment.

The matter will be considered on the receipt of their request.

(ii). Possession by the PWD

A note-sheet dated 25.04.2018 received from the general Admn. Branch has been put up by the office whereby it is informed that allotment of Chamber Nos.255,259 and 561 were cancelled by the Committee vide minutes of meeting held on 09.10.2017. However, till date possession has not been taken by the PWD so far.

The Administrative Civil Judge is requested to supervise the PWD for taking possession of the said cancelled chambers so that subsequent allotments can be made.

Any other Agenda with permissions to the Chair:-

1. Representation of Oath Commissioners

Joint Representation of Advocates working as Oath Commissioners dated 15.05.2018 has been put up by the Office. The Chairperson LCMC has been requested to look into the matter along with Ms. Savita Rao, Chairperson of Committee for Random Inspection of Oath Commissioners.

2. Request of Mr. Prem Mohan Bhatt for change of Chamber.

It is informed by the Office that a request has been made by Mr. Prem Mohan Bhatt, 2nd allottee of Chamber No.848 for change of chamber to 817. He has also enclosed the NOC given by Ms. Rita, 1st Allottee of Chamber No.817. Since the 2nd slot in Chamber No.817 is available for allotment and also the 1st allottee of chamber No.817 has given his NOC, request of Mr. Prem Mohan Bhatt is allowed. Accordingly, his name is incorporated in **List E-31 (Subsequent Allotment).**

3. Joint representation of Ms. Dipika Jain, Advocate 1st Allottee of Chamber No. 711 (under Initial Allotment) and Mr. Ashish Kumar Sharma, Advocate 1st Allottee of Chamber No. 437 (under Subsequent Allotment) for Common Chamber. They have preferred Chamber No.862.

The Committee considered the request. It is observed that Chamber No.862 is already allotted vide agenda Item No.07 of these minutes. As informed by the office, both slots in Chamber No.851 are available for allotment. The Members of the Committee unanimously resolved to allot the said chamber to Ms. Dipika Jain and Mr. Ashish Kumar Sharma as 1st and 2nd allottee(s) respectively. Accordingly, their names are incorporated in **List E-30 (Initial Allotment) and E-31 (Subsequent Allotment)**.

The meeting ended with vote of thanks.
