**CIRCULAR**

This is to inform that UVSS, RFID and Automatic Boom Barriers has to be installed at Gate No. 1, 2 & 3.

Initially, Gate No. 1 was closed for installation of the above said equipments, which is completed now. The said Gate No. 1 will be opened w.e.f. 27.12.2017 for light vehicles.

Further, Gate No. 2 will be closed w.e.f. 27.12.2017 for 25 days to execute the similar work as done at Gate No. 1. After opening Gate No. 1 & closing the periphery Gate No. 2 the movement of the vehicles in the Saket Court Complex till further orders, will be managed as under:-

- a) **Gate No. 1:** This gate will be used for entry of light vehicles of Advocates, Court Staff and employees of other organisations working in the Court Complex.
- b) **Gate No. 2:** This gate will be completely closed w.e.f. 27.12.2017 for 25 days.
- c) **Gate No. 3:** No change, this gate will be used as exit gate for vehicles.
- d) **Gate No. 6:** This gate will be used for entry/ exit of vehicles of Judicial Officers and Jail Van.

All the Judicial Officers, Administrative Officers (Judl.) and Branch In-charges posted in South and South East Districts, Saket Court Complex, New Delhi are hereby informed to direct all the staff posted under their control to adhere the above traffic arrangement.
