However, if not holding technical qualification, Officers who are tech-savvy, well versed with technological updates and proactive in using ECT tools in day to day court administration and are willing to be a trainer and take up various activities of the e-Court project may be nominated under this category (Judicial Officers recruited after 2015* may be considered under this category).

Category C -List of members of Court Staff with technical qualifications: List of Staff with technical qualification i.e. possessing *technical qualification in computer (BE; B.Tech, Bsc (CS), MCA, M.Tech) or Computer related fields Bachelor / Masters Degree in Data Science, Artificial intelligence etc.

Category D- List of Potential Master Trainer Court Staff: Staff holding diploma in computers or having completed certification courses in computer.

However, if not holding technical qualification, court staff who are tech-savvy, well versed with technological updates and proactive in using ECT tools in day to day court administration and are willing to be a trainer and take up various activities of the e-Court project may be nominated under this category (Staff recruited after 2015* may be considered under this category).

In view of aforesaid directions, it is hereby informed that all Ld. Judicial Officers and the Court Staff Officials who are willing to be nominated as new Potential Master Trainer for Category A or B and Category C or D respectively may send their willingness alongwith copy of Technical qualification to Computer Branch, Saket Court Complex, New Delhi by 23.04.2024.
