CIRCULAR

This is in continuation to this office earlier circular no. 19509-19729/CZ/Comp./2024 dated 20/03/2024 and to inform that new All-In-One DELL Optiplex 7410 Computer Systems have been received through Hon'ble High Court of Delhi under eCourts Project for installation exclusively in the courts of Delhi District Courts. The installation process of All-In-One Computer Systems have already been initiated by the Engineers of OEM/Supplier through Computer Branch of respective district/court complex.

In view of the above and to streamline the process of installation of All-In-One Computer Systems, all the Ld. Judicial Officers are requested to direct the staff/officials of respective court to receive supply of All-In-One systems (01 for Ld. Judicial Officer, 01 for Reader and 01 for each Stenographer/s).

In order to streamline the installation process of All-In-One Computer Systems, all concerned are hereby directed to:

1. Receive the supply of AIOs (One for Judicial Officer for VC, One for Reader and One for each Stenographer posted in the respective court) from the Computer Store-Room No. 278, 2nd Floor, Tis Hazari Courts, Main Building against proper receipt and record.
2. Remain present during the installation of All-In-One Computer Systems and to take data back-up of their existing Computer Desktop System before surrendering the same to the Computer Store and co-operate with Technical Team of OEM/Supplier of AIOs in installation process.
3. The Computer Branch or Technical Team of OEM/Supplier will not be responsible in any manner for loss of any data during installation process.
4. The stock of existing/replaced Computer Desktop Systems to kept by the user till further orders.
5. The request for providing of additional electricity/power points be addressed to the Care Taking Branch, Central District.
