Further, all the members of Bar are requested to take a note that the Hon'ble High Court vide order dated 24.02.2016 in the W.P.(civil) No. 7718/2015 and through the recent judgment dated 19.05.2024 restrain members of Bar from pasting of posters or installation of hoardings within and around any of the court complex, for their electoral prospects, else it advises prospective candidates to hold virtual meetings and use electronic media like whatsapp, etc. for their convessing for the elections.

Accordingly, members of Bar are advised to restrain from such unpleasant activities resulting shabby look to their workplace i.e. Saket Court Complex and are advised to remove their respective, if any, with immediate effect.

Following instructions are hereby issued in the interest of aesthetics of this court complex and in terms of directions of Hon'ble High Court of Delhi in its' above mentioned order & judgment:

- I) No Advocate/ prospective candidate(s) for election of SBA, shall be allowed to paste posters and/ or to install hoardings in and around this court complex. They are advised to use electronic media for their electoral prospects. In default thereof, such Advocates/ members of Bar shall liable to be disqualified from their candidature for any of the executive position in SBA, in terms of the judgment dated 24.02.2016 passed in W.P.(civil) No/ 7718/2015 titled as Pankaj Yadav V/S Union of India.
- II) No vehicle(s) containing posters/ hoardings on it, shall be allowed to enter or park in the court complex.
- III) Caretaking Branch with the help of Security Cell, Delhi Police Security and the nominated person(s) from the SBA, shall remove such hoardings and posters in and around Saket Court Complex, within a day or two and shall ensure that no such act is repeated.
- IV) Saket Bar Association, thereafter, shall take the responsibility to issue notice to such defaulting members of SBA and shall ensure that such act should not be repeated by it's members.
